ORDER OF LICENSE PROBATION

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his undersigned counsel and alleges and states as follows:

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.

2. Twila Dawn Winkler (“Respondent”) is an applicant for a resident insurance producer license in the State of Oklahoma. Her address of record is 123 N. Broadway, Moore, Oklahoma 73160.

3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code. 36 O.S. § 1435.13(A) and (D).

FINDINGS OF FACT

1. On or about June 6, 2016, Respondent applied for a resident insurance producer license with the Oklahoma Insurance Department.

2. Question 1(B) in the license application form asks the following: “Have you ever been convicted of a felony, had a judgment withheld or deferred, or are you currently charged with committing a felony?” Respondent answered the question “yes”.

3. If the question is answered “yes” the applicant must provide a written statement explaining the circumstances of the incident; a copy of the charging document; and a copy of the official document demonstrating resolution of the charges or any final judgment.

4. Respondent complied with these requirements and provided information showing that she has been convicted of three felony offenses (collectively referred to as “Respondent’s Criminal Matters”).

A. In Case number CF- 2012-2275 *State of Oklahoma v. Twila Dawn Winkler* Driving a Motor Vehicle while under the Influence of Alcohol – Aggravated (felony), Ms. Winkler was convicted and sentenced to five years in the Oklahoma Department of Corrections to run consecutively with CF-2010-1057 and CF-2010-1137.

B. In Case number CF-10-1057 *State of Oklahoma v. Twila Dawn Winkler* Driving a Motor Vehicle while under the Influence of Alcohol a Felony, Ms. Winkler plead guilty and was admitted to Cleveland County Drug Court Program. She was later terminated from the Drug Court Program and was sentenced to five years in the Oklahoma Department of Corrections to run concurrently with CF-2010-1137.

C. In CF-10-1137 *State of Oklahoma v. Twila Dawn Winkler* Driving Under the Influence of Alcohol a Felony, Ms. Winkler plead guilty and was admitted to Cleveland County Drug Court Program. She was later terminated from the Drug Court Program and was sentenced to five years in the Oklahoma Department of Corrections to run concurrently with CF-2010-1057.

5. Pursuant to 36 O.S. § 1435.13(A)(6), the Insurance Commissioner may revoke, censure, suspend, place on probation, or refuse to issue or renew an insurance producer license for having been convicted of a felony.

CONCLUSIONS OF LAW

Respondent complied with Insurance Code requirements by disclosing the criminal convictions against her. The Insurance Commissioner may place a licensee on probation. 36 O.S. § 1435.13(A) & (D).

ORDER

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that Respondent is granted a resident insurance producer license on a probationary status for the term period of the initial license. The probationary status shall be reviewed by the Insurance Commissioner at the time of first renewal. This Order shall be reported as an administrative action. Respondent is **ORDERED** to report any probation/parole violation as it relates to the Respondent's Criminal Matters immediately to the Commissioner. Respondent is **FURTHER ORDERED** to immediately report to the Commissioner any criminal charges filed against her. If Respondent violates any terms of this Order or any terms of her probation/parole in Respondent's Criminal Matters, her resident insurance producer licensed may be **REVOKED**.
