## **ORDER LIFTING SUSPENSION**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Lisa M. Torneten, and alleges and states as follows:

- 1. On June 16, 2016, a Conditional Administrative Order and Notice of Right to be Heard was issued. Chauncey Summers ("Respondent") was fined One Thousand and No/100 Dollars (\$1,000.00). The fine was to be paid within thirty (30) days of receipt of the Order or Respondent could request a hearing in the same amount of time. If the fine was not paid within the time allowed and a hearing was not requested, his bail bond license would be suspended.
- 2. Respondent failed to pick up the Order, which was mailed by certified mail to him at 535 E. Latimer Ct. Tulsa, Oklahoma 74106. Said Order was returned by the United States Postal Service ("USPS") on June 24, 2016 and marked "Return to Sender/Attempted—Not Known/Unable to Forward."
- 3. The Order was personally served upon Respondent at 5202 South Hudson Tulsa, Oklahoma 74113 on July 14, 2016.
  - 4. Respondent failed to pay the fine or request a hearing.
  - 5. On August 8, 2016, Respondent's license was suspended.

6. On August 14, 2017, the fine was paid.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that suspension of Chauncey Summers' bail bond license is hereby lifted.
