

5. Pursuant to *59 O.S. § 1310(B)*, in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

6. Pursuant to *59 O.S. § 1332(D)(4)(a)*, the Insurance Commissioner shall immediately cancel the license privilege and authorization of the insurer to do business within the State of Oklahoma and cancel the appointment of all surety bondsman agents of the insurer who are licensed by *Section 1301 et seq.* of this title.

5. If Respondents request a hearing in writing in this matter, pursuant to *OAC 365:1-7-1*, the Insurance Commissioner, pursuant to *36 O.S. § 319*, will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondents.

6. The Insurance Commissioner, pursuant to *OAC 365:1-7-5*, upon written request reasonably made by a person affected by the hearing and at such person's expense, shall cause a full stenographic record of the proceedings to be made by a competent court reporter.

ALLEGATIONS OF FACT

1. On or about April 19, 2016, an appearance bond was executed as follows:

2. On or about April 19, 2016, two appearance bonds were executed as follows:

Defendant: Lindell Leroy Calder
Case Number(s): CF-2016-2450
City/County: Tulsa County
Surety: Curtis Pletcher
Bondsman: Cynthia Aan-Rogers
Power Number(s): 92626 and 92628
Bond Amount(s): \$4,000.00 (92626) and \$100.00 (92628)

3. On June 13, 2016, the Defendant failed to appear in both CF-2016-652 and CF-2016-2450, and the bonds were declared forfeited. An Order and Judgment of Forfeiture was issued and filed in both cases by the Tulsa County District Court. A true and correct copy of the Order and Judgment of Forfeiture in CF-2016-652 and in CF-2016-2450 were mailed to Respondents on June 21, 2016 with return receipt requested.

5. Rogers received a copy of the Orders on June 28, 2016.

6. Pletcher received a copy of the Orders with the return filed on July 8, 2016.

7. The ninety-first (91st) day after receipt of the Orders was September 6, 2016.

8. As of the date of the filing of this Conditional Administrative Order, the forfeitures have not been paid and the defendant has not been returned to custody.

ALLEGED CONCLUSIONS OF LAW

1. Respondents have violated *59 O.S. § 1332* by failing to return the Defendant within ninety (90) days as specifically stated in subsection 4(c) of the statute or remit payment in the face amount of the bond forfeitures within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in case numbers CF-2016-652 and CF-2016-2450.

ORDER

IT IS THEREFORE ORDERED that Rogers and Pletcher are each FINED Two Hundred Fifty Dollars (\$250.00). The fines are to be paid within thirty (30) days made

payable to the Oklahoma Insurance Department. Payment may be made by either cashier's check or money order and sent to the Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. If the fines are not paid within thirty (30) days, Respondents' respective licenses will be suspended and shall remain suspended until the fines are paid in full.

IT IS FURTHER ORDERED that Respondent is to pay the forfeitures in Tulsa County case numbers CF-2016-652 and CF-2016-2450, State v. Lindell Leroy Calder. If the forfeitures are not paid within thirty days, pursuant to 59 O.S. § 1332(D), the Oklahoma Insurance Department is ordered to withdraw the face amount of the bonds, Six Thousand One Hundred and No/100 Dollars (\$6,100.00) respectively, from Pletcher's professional bail bondsman certificate of deposit and forward it to the Tulsa County Court Clerk for payment of the bond forfeiture.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondents request a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in writing addressed to Sara A. Worten, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases

under the Insurance Code and 75 O.S. § 250-323. If the Respondents serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.

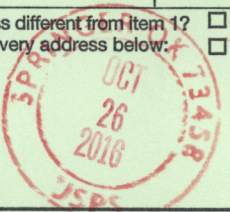
