5. On November 2, 2015, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on November 3, 2015, by the Nowata County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Faust and ACIC with return receipt requested within thirty (30) days after the Order's filing.

6. The Order and Judgment of Forfeiture sent to Faust was unclaimed.

7. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was February 12, 2016.

8. As of January 31, 2016, the forfeiture has not been paid nor has the defendant been timely returned to custody.

9. Respondent voluntarily submits to the jurisdiction of OID without a hearing and enters into this Stipulation and Agreed Order.

10. Respondent acknowledges the above stipulations of fact and the agreed conclusions of law and agrees to pay the amount of the Order and Judgment of Forfeiture to the Nowata Court Clerk and an administrative fine in the amount of **Two Hundred and Fifty Dollars (\$250.00)** in settlement of the matters alleged herein.

AGREED CONCLUSIONS OF LAW

11. Respondent has violated 59 O.S. § 1310(A)(2) and (28), by failing to return the Defendant to custody within ninety (90) days or remit payment in the face

amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41.

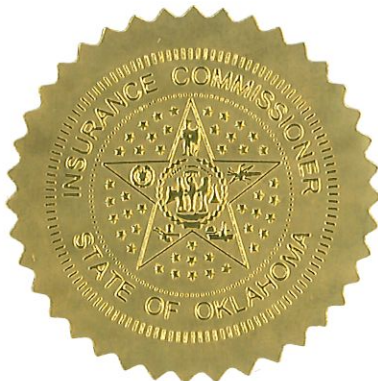
12. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a fine of not less than Two Hundred and Fifty Dollars (\$250.00) but not more than Two Thousand and Five Hundred Dollars (\$2,500.00) per violation.

AGREED ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner, and **CONSENTED TO** by Respondent, that:

1. Respondent has violated 59 O.S. §§ 1310 and 1332 and is subject to a penalty for that conduct.
2. Respondent is fined in the amount of Two Hundred and Fifty Dollars (\$250.00), which is due upon entry of this Agreed Order.
3. Respondent further agrees that the amount of the forfeiture provided herein shall be paid in full prior to entry of this Agreed Order.


