CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, and the Respondents, Bryan Bullard and John Burks, and enter into this Consent Order.

JURISDICTION

1. That the Insurance Commissioner has jurisdiction over this cause, pursuant to the provisions of the Oklahoma Bail Bond Code, OKLA. STAT. tit. 59, §§ 1301-1340.
2. That Respondent Bryan Bullard (“Bullard”) is a licensed bail bondsman in the State of Oklahoma holding license number 100105866.
3. That Respondent John Burks (“Burks”) is a licensed multicounty agent bail bondsman in the State of Oklahoma holding certificate of authority number 199080.
3. That Respondents Bullard and Burks have been apprised of their rights including the right to a public hearing and have knowingly and freely waived said rights and enters into

this Consent Order as a voluntary settlement to the issues and questions raised in the above captioned case.

STIPULATIONS OF FACT

1. On or about June 3, 2016, an appearance bond was executed as follows:

Defendant:	Bethany Joy Moore
Case Number(s):	6014252
City/County:	Tulsa Municipal Court
Surety:	John Burks
Bondsman:	Bryan Bullard
Bond Number(s):	23298
Bond Amount(s):	\$500.00

2. On August 15, 2016, the Defendant failed to appear, and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case August 18, 2016 by the Tulsa Municipal Court Clerk ordering Respondents to pay the bond amount of \$500.00 to the Tulsa Municipal Court Clerk. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents on August 19, 2016 with return receipt requested.
3. Bullard received a copy of the Order and Judgment of Forfeiture on August 22, 2016.
4. Burks received a copy of the Order and Judgment of Forfeiture on September 7, 2016.
5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was November 21, 2016.
6. The forfeiture was paid December 28, 2016.

CONCLUSIONS OF LAW

1. Respondents have violated 59 O.S. § 1332 by failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondents that they shall be and hereby is fined in the amount of Five Hundred Dollars (\$500.00) each. The fine is to be paid immediately.



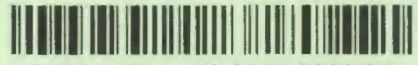
