IF NECESSARY, YOU WILL BE GIVEN AN OPPORTUNITY TO COMPLETE OR CHALLENGE THE ACCURACY OF THE INFORMATION CONTAINED IN THE REPORT OF THE OSBI AND FBI. THE PROCEDURE FOR OBTAINING A CHANGE, CORRECTION, OR UPDATING OF AN FBI IDENTIFICATION RECORD ARE SET FORTH IN TITLE 28, CFR, 16.34. IF THE APPLICANT RECEIVES A DOCUMENT THAT UPDATES THE CRIMINAL HISTORY RECORD, THE APPLICANT SHOULD FORWARD A CERTIFIED COPY OF THE DOCUMENT TO THE FBI AND THE REPOSITORY IN THE STATE WHERE THE ARREST OCCURRED.

THE REAL ESTATE APPRAISER BOARD WILL NOT DENY YOUR APPLICATION UNTIL YOU HAVE BEEN AFFORDED A REASONABLE OPPORTUNITY TO CORRECT OR COMPLETE THE RECORD, OR UNTIL YOU HAVE DECLINED TO DO SO.
