- UCAA Form 17 Statement of Withdrawal.

Rate and Form Filings: Please assure rate and form filings have been completed electronically through SERFF. File Electronically through the <u>NAIC's SERFF System</u> - 180 day notice for Life Insurers or 90 day notice for Property and Casualty Insurers including the following:

- 1. The insurer shall state in writing its reasons for such action.
- 2. The number of policyholders affected;
- 3. The number of insurance agents affected;
- 4. The date the insurer will cease writing new business;
- 5. The date the insurer will start non-renewing insurance policies;
- 6. The date the insurer will transfer policyholders; if applicable;
- 7. Whether the insurer has made arrangements with another insurer to pick up the renewals; if applicable;
- 8. The lines of insurance on which the insurer plans to concentrate; and
- 9. Whether the insurer anticipates re-entering the market.

- Surrender the current Certificate of Authority for amendment (must be original or the UCAA or file Form 15 Affidavit of Lost Certificate of Authority) – no fee.
- **Fees:** Mail the check with a cover letter and the Certificate of Authority (or Form 15). Checks must be **payable to the OKLAHOMA INSURANCE DEPARTMENT** and arrive with paperwork to assure the payment can be applied properly.

Note: All fees noted above apply unless the retaliatory fee is higher pursuant to Title 36 O.S. § 628.
