## **BOARD ORDER MODIFYING BOARD ORDER 11-027**

ON THE 30<sup>th</sup> day of March, 2012 the above numbered and entitled cause came on for hearing before the Oklahoma Real Estate Appraiser Board (the "Board") pursuant to the written request of Jack N. Tresner filed on March 2, 2012. Mr. Tresner's March 2, 2012 correspondence requests modification of Board Order 11-027 as it pertains to the time allotted in which to complete Course #612 – Residential Site Valuation and Cost Approach. The 180 days allotted to Mr. Tresner under Board Order 11-027 to complete those corrective education courses expires on April 4, 2012.

Mr. Tresner completed Course #611 on February 12, 2012 and has timely submitted his course completion certificate to Board staff. As he has been unable to locate an approved provider who has scheduled Course #612, Mr. Tresner requests an additional 90 days up to and including July 1, 2012 in order that he can complete the remaining corrective education course.

The Board, being fully advised in the matter, makes the following Order adopting the Panel's Recommendation.

## JURISDICTION

 That the Oklahoma Real Estate Appraiser Board has jurisdiction of this cause, pursuant to the provisions of the Oklahoma Certified Real Estate Appraiser Act, 59 O.S. § 858-700 et seq.

WHEREFORE, the Board hereby orders that Mr. Tresner is granted an additional period of time, up to and including August 1, 2012 in which to complete the remaining corrective education which was previously ordered under Board Order 11-027.

Should Respondent fail to comply with any of the terms and conditions set forth in Order 11-027 as modified herein, the Board's Director shall suspend Respondent's appraiser credential instanter; shall immediately notify the Respondent of said suspension by certified mail, return receipt requested; and shall immediately notify the National Registry of such suspension; and the credential shall remain suspended until such time as Respondent is in full compliance.
