## BOARD ORDER AS TO NOTICE TO APPEAR AND ORDER TO SHOW CAUSE

On the 6th day of March, 2013 the above-referenced matter comes on for hearing before the Oklahoma Real Appraiser Board (the "Board") pursuant to the Notice to Appear and Order to Show Cause issued by the Board's Director, Christine McEntire, on the 4<sup>th</sup> day of February, 2013. Said Notice and Order to Show Cause was issued with respect to the Final Order provisions for corrective education under Board Order 11-028 effective November 4, 2011 as follows:

"Each Respondent shall successfully complete corrective education as set forth below. Such courses shall be completed within one (1) year following entry of any final order in this matter with certificates of course completion furnished to the administrative office of the Board. Courses shall be Board-approved courses taken from a Board-approved course provider and may be used for credit as continuing education required for credential renewal. Courses to be taken shall be as follows:

- a. Course #600 National USPAP (15 Hours);
- b. Course #611 Residential Market Analysis and Highest & Best Use 15 Hours.";

and non-compliance with Board Order 12-024, dated December 7, 2012, which granted both Respondents, Jeffrey D. Phillips and Zachary A. Phillips, an additional period of time until February 1, 2013 to properly complete the required corrective education issued in Board Order 11-028.

As of the day of this hearing, neither Respondent has produced course completion certificates for the corrective education imposed against them.

Neither Respondent appeared at today's hearing as summoned.

The Board, being fully advised in the matter, hereby Orders as follows:

ORDER 13-005

<u>JURISDICTION</u>

1. That the Board has the duty to carry out the provisions of the Oklahoma Certified

Real Estate Appraisers Act as set forth at Title 59 of the Oklahoma Statutes, §§858-701, et seq.

and to establish administrative procedures for disciplinary proceedings conducted pursuant to

the provisions of the Oklahoma Certified Real Estate Appraisers Act.

That at the time of issuance of Board Order 11-028 and Board Order 12-024,

Respondent JEFFREY D. PHILLIPS was a Certified Residential Appraiser in the State of

Oklahoma, holding credential number 12646CRA and was first licensed with the Oklahoma Real

Estate Appraiser Board on September 12, 2005. Respondent, Jeffrey D. Phillips is currently an

inactive appraiser, having been revoked on February 11, 2013, and no action is taken at this

time.

3. That Respondent ZACHARY A. PHILLIPS is a Trainee Appraiser in the State of

Oklahoma, holding credential number 90940TRA and was first credentialed with the Oklahoma

Real Estate Appraiser Board on November 7, 2007.

WHEREFORE, IT IS HEREBY ORDERED that License Number 90940TRA, issued to

Respondent, Zachary A. Phillips, is hereby revoked due to non-compliance with Board Orders.

THE BOARD WISHES TO ADVISE THE RESPONDENT, ZACHARY A. PHILLIPS, THAT HE

HAS THIRTY (30) DAYS TO APPEAL THIS ORDER WITH THE APPROPRIATE DISTRICT

COURT.
