The filing number will then be converted to the SERFF filing number by Department staff at their earliest convenience.

Some of the filings will contain fewer than ten (10) pages while others will have hundreds. As such, it is the company's responsibility to set limitations as to the amount of the total expenditure.

Although appointments are not required to view filings, it is highly suggested due to the limited space and equipment. Individuals making appointments will be given priority access to the SERFF computer and any remaining paper filings. Anyone who does not make an appointment may wait in the lobby or make an appointment for another time period.
