<u>Update: Oklahoma Updating Adjuster Designated Home State (ADHS) Rules, Lines of Authority and Non Uniform</u> **Questions**

Effective November 9, 2018 Oklahoma will modify the Adjuster Designated Home State Rule (ADHS) rules for the Non Resident Adjuster License (NRAL), Non-Resident Adjuster Renewals (NRAR) applications, update Non Uniform Questions and convert lines of authority to Producer Licensing Model Act standards.

Please note - The Non Uniform Question section has been updated since the original posting of this notification. In addition, the removal of fee proration will not be completed at this time. Please see changes below in red font.

Transactions will be turned off Thursday November 8, 2018 at 5:00 PM CDT during the release and will be turned back on Monday November 12, 2018 by 8:00 AM CDT.

Update: Oklahoma Updating Adjuster Designated Home State (ADHS) Rules and Updating Lines of Authority

The changes originally scheduled for August 10th, 2018 have been delayed. We will be making only a single change to the Oklahoma's Appointments and Terminations.

Beginning August 10th, 2018, Oklahoma will require all appointment and terminations applications to submit the license number of the appointer's active Oklahoma license. Oklahoma appointments and terminations applications submitted using the number of an inactive license will be rejected.

Effective August 10, 2018 Oklahoma will be making the following business rule modifications:

- For Adjuster Designated Home State Rule (ADHS) for the Non Resident Adjuster License (NRAL) and Non-Resident Adjuster Renewals (NRAR) applications, Applicants desiring to designate Oklahoma as their designated home state (DHS) will now be instructed to use Oklahoma's no home state (NHS) application.
- Oklahoma will no longer be prorating fees for all resident and non-resident initial and renewal applications.
- P.O. Boxes are not accepted for resident or business addresses for all individual license and renewal applications.
- For business license and renewal applications, P.O. Box addresses will not be accepted for business address.
- The Designated Individuals must cumulatively cover the lines of authority for the license class on the business license
 and renewal applications for resident and nonresident and business applicants must provide at least one individual
 owner on application.
- If applying for Managing General Agent (PDB Code 351) the non-resident license application the applicant must hold an active Insurance Producer (PDB Code 3) license in Oklahoma.
- Applicants applying for the Professional (PDB code 3450) line of authority must have previously held the LOAs Surety Bail (PDB code 3453), Cash (PDB code 3442), and Property Bail (PDB code 5992) for two years before eligible to apply.
- For the appointments and terminations application the Appointer license number must be active.
