Title 36:15-9-9 Medical practice rate change application is a public record. All parts of a rate change application submitted by an insurer pursuant to 36 O.S. §6821 shall be a public record upon receipt by the Insurance Department. An insurer may not make an assertion of confidentiality for any part of a rate change application.

Title 36 O.S. 987F. A filing and any supporting information required to be filed shall be open to public inspection once the filing becomes effective except information marked confidential, trade secret, or proprietary by the insurer or filer.

PURPOSE OF THIS BULLETIN

The Rate and Form Compliance Division of the Oklahoma Insurance Department (“Department”) has developed a monthly report of the filing activities of property and casualty insurers admitted in the State of Oklahoma. The monthly reports may be used to monitor the Oklahoma property and casualty insurance marketplace.

The reports will be posted on the Department’s website on a monthly basis. For your convenience, each document will be in **searchable** format.

The Department will provide copies in electronic format of public documents contained in any filing at a cost of \$0.40 per page, plus additional costs as appropriate. The Department will accommodate requests for public documents in other formats as needed. In addition to all other charges, a search fee may be charged when records are requested for commercial purposes or when responding to a request would be excessively disruptive to the essential functions of the Department. Postage costs must also be paid by the requestor. Requests should be emailed to **both** Linda.Valliant@oid.ok.gov and Cuc.Nguyen@oid.ok.gov

The request **must** identify the OID and/or Sircon number for filings submitted from 2005 through June 2011. Requests for filings submitted after June 2011 **must** identify the SERFF and/or Sircon filing number. The SERFF and/or Sircon filing number is identified on the report for each filing. (Example – Filing: ABCD-127123586 and/or 31769). All requests must identify the lead insurance company and the month the filing was posted.

Some filings will contain fewer than ten (10) pages while others will contain hundreds. It is the requestor’s responsibility to inform the Department of limitations as to the number of pages for which the requestor is willing to pay.

The Department’s SERFF computer may be used by the public to view filings. **Although appointments are not required to view filings, it is strongly suggested due to the limited amount of space and equipment. Individuals making appointments will be given priority access to the SERFF computer.**
