PURPOSE OF THIS NOTICE

The Rate and Form Compliance Division of the Oklahoma Insurance Department ("Department") has developed a monthly report of the filing activities of property and casualty insurers admitted in the state of Oklahoma. The monthly reports may be used to monitor the Oklahoma property and casualty insurance market place.

The reports will be posted on the Department's website on a monthly basis. For your convenience, each document will be in **searchable** format.

The Department will provide copies in electronic format of public documents contained in any filing at a cost of \$0.40 per page, plus additional costs as appropriate. The Department will accommodate requests for public documents in other formats as needed. In addition to all other charges, a search fee may be charged when records are requested for commercial purposes or when responding to a request would be excessively disruptive to the essential functions of the Department. Postage costs must also be paid by the requestor. Requests should be e-mailed to Linda.Valliant@oid.ok.gov or Paula.Butler@oid.ok.gov.

The monthly reports currently do not include the SERFF filing number. As such, we strongly suggest that you submit your request well in advance of your deadline to allow sufficient time to locate the requested filing.

The request **must** identify the OID and/or SIRCON number for filings submitted from 2005 through June 2011. Requests for filings submitted after June 2011 **must** identify the SERFF and/or SIRCON filing number. The SIRCON filing number is identified on the report for each filing. (Example - Filing: 31769). All requests must identify the lead insurance company and the month the filing was posted.
