The request <u>must</u> identify the OID and/or SIRCON number for filings submitted from 2005 through June 2011. Requests for filings submitted after June 2011 <u>must</u> identify the SERFF and/or SIRCON filing number. The SERFF and/or SIRCON filing number is identified on the report for each filing. (Example - Filing: ABCD-127123586 and/or 31769). All requests must identify the lead insurance company and the month the filing was posted.

Some filings will contain fewer than ten (10) pages while others will contain hundreds. It is the requestor's responsibility to inform the Department of limitations as to the number of pages for which the requestor is willing to pay.

The Department's SERFF computer may be used by the public to view filings. Although appointments are not required to view filings, it is strongly
