BOARD'S ORDER MODIFYING ORDER 08-007

On the 10th day of April, 2009 the above-numbered and entitled cause came on for hearing before the Oklahoma Real Estate Appraiser Board (the "Board") pursuant to Respondent's written request to modify Board Order 08-007, effective March 7, 2008. Prosecutor, Stephen McCaleb, appeared on behalf of the Real Estate Appraiser Board. Respondent, Diane L. Schumacher, appeared not.

The Board, after considering all evidence and argument, and being fully advised thereto, hereby makes the following Findings of Fact:

This Order is issued pursuant to the Oklahoma Real Estate Appraiser Act, Title 59 Section 858-700 et seq. of the Oklahoma Statutes.

FINDINGS OF FACT

After hearing all the evidence presented and upon due consideration thereof, the Board finds by clear and convincing evidence that:

- Respondent, Diane L. Schumacher, is a State Licensed Real Estate Appraiser in the State
 of Oklahoma, holding credential number 10937SLA and was first credentialed with the Oklahoma Real
 Estate Appraiser Board on June 2, 1993.
- 2. On March 7, 2008, the Board approved Order 08-007 as to Complaint No. 05-091, ordering Ms. Schumacher to successfully complete, as corrective education from a sponsoring organization of the Appraisal Foundation, A.) The tested 15-hour National USPAP course; and B.) an ANSI course on measuring gross living area. The Order provided that Ms. Schumacher would have three (3) months from the date of the Board Order to complete the corrective education.

- 3. On June 9, 2008 after Respondent failed to meet the conditions of Board Order 08-007 her appraiser credential was suspended.
- 4. On June 30, 2008 the Respondent's appraiser credential expired without Ms. Schumacher paying her annual fees.
- 5. On or about June 30, 2008 Board staff received course completion certificates from the Respondent for both courses, which were taken at Tulsa Technology Center and the Academy of Real Estate respectively.
- 6. On July 1, 2008 Board staff sent correspondence to Ms. Schumacher advising her that the certificates of course completion do not meet the conditions specified by the Final Order in Board Order 08-007 in that Tulsa Technology Center and the Academy of Real Estate are not sponsoring organizations of The Appraisal Foundation, and advising her that her suspension remains in effect.
- 7. On January 30, 2009 Board staff received correspondence from Ms. Schumacher in which she requested that the suspension on her license be lifted due to economic hardship and her belief that she substantially completed the request of the Board in taking the 15-Hour National USPAP course and an ANSI course, albeit not from a sponsoring organization of the Appraisal Foundation.

CONCLUSIONS OF LAW

The Board has jurisdiction to hear this matter pursuant to Title 59 Sections 858-700 et seq. of the Oklahoma Statutes.

The Board concludes that Respondent violated an Order of the Board, in violation of the Real Estate Appraiser Act, and that her suspension was made with just cause.



ORDER

IT IS THEREFORE ORDERED by the Oklahoma Real Estate Appraiser Board that Respondent's ten (10) month suspension is now lifted.

IT IS FURTHER ORDERED that Respondent's credential will be reinstated upon payment of her annual licensing fees totaling \$325.00 and a reinstatement fee in the amount of \$50.00, which were due June 30, 2008 and course completion certificates showing an additional 14 hours of continuing education as mandated by the Appraiser Qualification Board, Generic Education Criteria F(3).
