**AGREED ORDER OF CONSENT**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Julie Meaders, and Kyle Carter, a licensed bail bondsman in the State of Oklahoma, and Dustin Pletcher, a professional bail surety in the State of Oklahoma, and agree to the entry of this Consent Order and jointly state as follows:

**JURISDICTION**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 *et seq.* and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301 *et seq.*
2. Respondent Kyle Carter (“Carter”) is a licensed bail bondsman in the State of Oklahoma holding license number 100179746.
3. Respondent Dustin Pletcher (“Pletcher”) is a professional bail surety in the state of Oklahoma holding license number 40070339.

4. The Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act and/or may levy a fine of not less than \$250.00 but not more than \$2,500.00 for each occurrence of a violation of the Oklahoma Bail Bond Act. *59 O.S. §§ 1310(A) and (B).*

**STIPULATIONS OF FACT**

1. On or about February 28, 2016, an appearance bond was executed as follows:

Defendant:	Devin Michael Salley

City/County:	Oklahoma County, Oklahoma
Surety:	Dustin Pletcher
Bondsman:	Kyle Carter
Power Number(s):	5455
Bond Amount(s):	\$4,500.00

2. On September 14, 2016, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on March 28, 2016, by the Oklahoma County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Carter and Pletcher, with return receipt requested, within thirty (30) days after the Order’s filing.

3. Carter received a copy of the Order and Judgment of Forfeiture on September 28, 2016.

4. Pletcher received a copy of the Order and Judgment of Forfeiture on October 11, 2016.

5. The ninety-first (91<sup>st</sup>) day after receipt of the Order and Judgment of Forfeiture was December 28, 2016.

6. The face amount of the forfeited bond was not deposited with the Court Clerk by this date.

7. No notice was given to the Oklahoma County Court that defendant was in custody in another jurisdiction by December 28, 2016.

**AGREED VIOLATIONS OF LAW**


1. Respondents have violated *59 O.S. § 1310(A)(2)* and *OAC 365:25-5-44* by failing to file notice with the Oklahoma County Court Clerk by the ninety-first day after receipt of the Order and Judgment of Forfeiture, certifying that the defendant was returned to custody by the ninetieth day after receipt of the Order and Judgment of Forfeiture.

2. Pursuant to *59 O.S. § 1310(B)*, any bondsman violating a provision of the Bail Bond Act, *59 O.S. §§ 1301-1340*, may be subject to a fine of not less than \$250 but not more than \$2,500 per violation.

**ORDER AND CONSENT**

**IT IS THEREFORE ORDERED** by the Insurance Commissioner and **CONSENTED** to by Respondents that each be fined in the amount of **FIVE HUNDRED DOLLARS (\$500.00)** for the above described violations of the Oklahoma Bail Bond Code and the Oklahoma Insurance Code.
