STIPULATION AND AGREED ORDER

COMES NOW Sandra LaVenue, Senior Counsel for the Oklahoma Insurance Department ("OID"), Rianne Hamilton ("Hamilton"), and Curtis Pletcher ("Pletcher"), who stipulate and agree to the following findings of fact and conclusions of law.

JURISDICTION

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1341.

2. Respondent Hamilton is a licensed bail bondsman in the State of Oklahoma holding license number 40088144.

3. Respondent Pletcher is a professional bail bondsman in the state of Oklahoma holding license number 199574.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. § 1310.

AGREED FINDINGS OF FACT

5. On or about November 8, 2016, an appearance bond was executed as follows:

City/County:	Tulsa County
Surety:	Curtis Pletcher
Bondsman:	Ryanne Hamilton
Power Number(s):	106472
Bond Amount(s):	\$500.00

6. On December 19, 2016, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on December 22, 2016, by the Tulsa County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Hamilton and Pletcher at their address of record on file with the Oklahoma Insurance Department with return receipt requested within thirty (30) days after the Order's filing.

7. Hamilton's Order and Judgment of Forfeiture was returned unclaimed on January 25, 2017.

8. Pletcher received a copy of the Order and Judgment of Forfeiture on December 29, 2016.

9. The ninety-first (91st) day after receipt of the Order and Judgment of

forfeiture was March 30, 2017.

10. The forfeiture was paid on or about April 4, 2017, which was approximately four (4) days past the date that the forfeiture was due.

11. Respondents voluntarily submit to the jurisdiction of OID without a hearing and enter into this Stipulation and Agreed Order.

12. Respondents acknowledge the above stipulations of fact and the agreed conclusions of law and each agree to pay an administrative fine in the amount of Five Hundred Dollars (\$500.00).

AGREED CONCLUSIONS OF LAW

13. Respondents Hamilton and Pletcher have violated 59 O.S. § 1310(A)(2) and (28) by violating the provisions of 59 O.S. § 1332 and by failing to pay fees due to a district court clerk as required by the Oklahoma Bail Bond Act, 59 O.S. § 1301-1341.

14. Respondent Hamilton violated the provisions of 59 O.S. § 1310(A)(32) for failing to accept or claim a certified mailing from the Tulsa County Court Clerk which was addressed to Hamilton's mailing address on file with the Oklahoma Insurance Department.

15. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a fine of not less than \$250.00 but not more than \$2,500.00 per violation.

AGREED ORDER

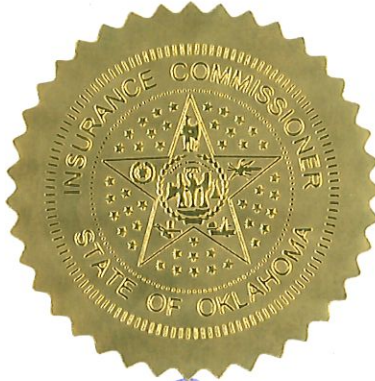
IT IS THEREFORE ORDERED by the Insurance Commissioner, and **CONSENTED TO** by Respondents Hamilton and Pletcher that:

1. Both Respondents Hamilton and Pletcher violated the provisions of 59 O.S. §§ 1310 and 1332.

2. That Hamilton violated the provisions of 59 O.S. § 1310(A)(32).

3. Respondent Hamilton and Respondent Pletcher are each assessed an administrative fine in the amount of Five Hundred Dollars (\$500.00), which is due upon entry of this Agreed Order.
