### **ADMINISTRATIVE ORDER**

This matter is a proceeding under the Oklahoma Bail Bond Code, 59 O.S. §§ 1301 et seq., the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., and conducted pursuant the Oklahoma Administrative Procedures Act, 75 O.S. §§ 301 et seq, whereby Respondent, Michael Anthony Frommung ("Respondent") is an Oklahoma licensed bail bondsman in the state of Oklahoma holding license number 100215554. On August 3, 2017, the Oklahoma Insurance Department ("OID") issued a Notice of Hearing and Order For Show Cause alleging violations of the provisions of Title 59 of the Oklahoma Statutes and setting this matter for hearing on August 24, 2017, at 9:30 a.m. at the office of the Oklahoma Insurance Department, 3625 N.W. 56<sup>th</sup> Street, Suite 100, Oklahoma City, Oklahoma. Legal service of summons was achieved by serving Respondent on August 10, 2017, by certified mail return receipt requested.

On August 24, 2017, the above captioned case came on for hearing at the Oklahoma Insurance Department. Oklahoma Insurance Commissioner John D. Doak appointed the undersigned independent Hearing Examiner, John D. Miller, to preside at

the hearing as a quasi-judicial officer pursuant to 59 O.S. § 1311.1(B). The hearing was recorded electronically by employees of OID. Petitioner was represented by Senior Counsel Sandra G. LaVenue. Neither Respondent nor a representative for Respondent appeared at the hearing. Testimony and evidence was heard before the undersigned Hearing Examiner including the admission of exhibits into evidence. Therefore, after consideration of the testimony and evidence presented, this independent Hearing Examiner issues his order of findings of fact and conclusions of law.

#### FINDINGS OF FACT

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and as such is charged with the duty of administering and enforcing all provisions of the Oklahoma Bail Bond Code.
- 2. The Insurance Commissioner, pursuant to 59 O.S. § 1311.1(B), appointed an independent Hearing Examiner and that Hearing Examiner has the jurisdiction to determine if there is evidence to support a finding by clear and convincing evidence that Respondent's actions as alleged in the OID Notice of Hearing and Order for Show Cause issued on August 3, 2017, were established by the evidence and were in violation of the Oklahoma Bail Bond Code.
- 3. That Respondent received notice of this administrative action via certified mail return receipt requested at the Jess Dunn Correctional Center in Taft, Oklahoma.
- 4. On May 8, 2017, Respondent entered a guilty plea to a felony; specifically, contributing to the delinquency of a minor in Comanche County, Oklahoma, case number CF-2015-387.

### **CONCLUSIONS OF LAW**

- 5. Respondent violated the provisions of 59 O.S. § 1310(A)(5) by pleading guilty and convicted of a felony.
- 6. Respondent is hereafter prohibited from performing any acts of a bail bondsman pursuant to 59 O.S. § 1315(A)(1).

## **ORDER**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that it has been established by clear and convincing evidence that Respondent violated 59 O.S. § 1310(A)(5) of the Oklahoma Bail Bond Code due to his conviction of a felony and as a result, Respondent's bail bond license is hereby REVOKED.




