# CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel, and alleges and states as follows:

### JURISDICTION AND AUTHORITY

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1341.
- 2. Respondent Michael Garner ("Garner") is a licensed bail bondsman in the State of Oklahoma holding license number 100239594.
- 3. Respondent Joe Nelson ("Nelson") is a licensed multicounty agent bondsman in the State of Oklahoma holding license number 199225.
- 4. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to

a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

#### **ALLEGATIONS OF FACT**

1. On or about April 4, 2016, an appearance bond was executed as follows:

2. On January 4, 2017, the Defendant failed to appear in case number CM-2015-1490 and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case by the Comanche County Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondents on January 10, 2017 with return receipt requested.

- 3. Garner received a copy of the Order with the return filed on January 17, 2017.
- 4. Nelson received a copy of the Order with the return filed on January 12, 2017.
- 5. The ninety-first (91<sup>st</sup>) day after receipt of the Order was April 18, 2017.
- 6. On April 7, 2017, an Order to Stay Payment of Monies for ninety (90) days was issued by the Comanche County Court in case number CM-2015-1490. The forfeiture was ordered to be returned by July 6, 2017.
- 7. As of the date of the filing of this Conditional Administrative Order, the forfeiture has not been paid and the defendant has not been returned to custody.

### **ALLEGED VIOLATIONS OF LAW**

1. Respondents Garner and Nelson have failed to comply with 59 O.S. § 1332(D)(1) by

failing to return the Defendant within ninety (90) days or remit payment in the face amount of the bond forfeiture within the additional ninety (90) days from the Order to Stay Payment of Monies in case number CM-2015-1490, which is a violation under 59 O.S. § 1310(A)(2).

2. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a fine of not less than Two Hundred and Fifty Dollars (\$250.00) but not more than Two Thousand and Five Hundred Dollars (\$2,500.00) per violation.

#### **ORDER**

IT IS THEREFORE ORDERED that Garner and Nelson are <u>each</u> FINED Five Hundred and No/100 Dollars (\$500.00). The fines are to be paid within thirty (30) days made payable to the Oklahoma Insurance Department. Payment may be made by either cashier's check or money order and sent to the Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112.

IT IS FURTHER ORDERED that Respondents Garner and Nelson are to pay the forfeiture in Comanche County case number CM-2015-1490, *State v. David Easley*. If the forfeiture is not paid within thirty (30) days, pursuant to 59 O.S. § 1332(D), the Oklahoma Insurance Department is ordered to withdraw the face amount of the bond, One Thousand and No/100 Dollars (\$1,000.00) from Nelson's multicounty bail bondsman certificate of deposit and forward it to the Comanche County Court Clerk for payment of the bond forfeiture.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondents request a hearing

with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in writing addressed to Lisa M. Torneten, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250-323. If the Respondents serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
