**CONDITIONAL ADMINISTRATIVE ORDER**  
**AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Lisa M. Torneten, and alleges and states as follows:

**JURISDICTION & AUTHORITY**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq, including the Oklahoma Producer Licensing Act, 36 O.S. §§ 1435.1 through 1435.41.

2. Martin E. Bradshaw & Associates, Inc. (“Respondent”) was formerly a licensed foreign business entity producer in the State of Oklahoma holding license number 10014799. Respondent’s address of record is P.O. Box 627 Marianna, Arkansas.

3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code pursuant to 36 O.S. §§ 1435.13(A) and (D).

**ALLEGATIONS OF FACT**

1. Respondent's license expired May 31, 2017.
2. On September 5, 2017, Respondent submitted an application to the Oklahoma Insurance Department ("The Department") to reactivate its license.
3. On September 7, 2017, the Department sent a letter to Respondent requiring a detailed response as to how many policies were sold and serviced under the entity name Martin E. Bradshaw & Associates, Inc. as of May 31, 2017.
4. Respondent submitted a response to the Department listing two (2) individual policies which were sold, serviced or negotiated since May 31, 2017, after the expiration of its license.

**ALLEGED VIOLATIONS OF LAW**

1. Respondent violated 36 O.S. § 1435.4(A), selling, soliciting or negotiating insurance in this state without a license, a violation of 36 O.S. § 1435.13(A).

**ORDER**

**IT IS THEREFORE ORDERED** by the Insurance Commissioner that Martin E. Bradshaw & Associates, Inc. is **FINED FIVE HUNDRED AND NO/100 DOLLARS (\$500.00)**. **The \$500.00 fine is to be paid within thirty (30) days** made payable to the Oklahoma Insurance Department.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above shall become a Final Order on the thirty-first day following the date of mailing this Order. A request for hearing should be in

writing addressed to Lisa M. Torneten, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing shall be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250-323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
