CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, and the Respondents, Ryanne Hamilton and Curtis Pletcher, and enter into this Consent Order.

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Ryanne Hamilton ("Hamilton") was a licensed bail bondsman in the State of Oklahoma holding license number 40088144. Hamilton's license expired October 31, 2017. Hamilton's address of record is 6236 N. Troost Avenue, Tulsa, Oklahoma 74126.
- 3. Respondent Curtis Pletcher ("Pletcher") is a professional bail bondsman in the state of Oklahoma holding license number 199574. Pletcher's address of record is P.O. Box 66,

Springer, Oklahoma 73458-0066.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.

5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

STIPULATIONS OF FACT

1. On or about June 6, 2016, an appearance bond was executed as follows:

- 2. On or about August 2, 2016, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about August 4, 2017, by the Creek County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Hamilton and Pletcher with return receipt requested within thirty (30) days after the Order's filing.
- 3. Hamilton received a copy of the Order and Judgment of Forfeiture on August 10, 2016.
- 4. Pletcher received a copy of the Order and Judgment of Forfeiture on August 11, 2017, 2016.

- 5. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was November 9, 2016 and extended by Orders of the Court to April 7, 2017. Respondent's third Motion for Extension of Time was filed after April 7, 2017.
- 6. The forfeiture was untimely paid on October 06, 2017, and the defendant was not timely returned to custody.

CONCLUSIONS OF LAW

1. Hamilton and Pletcher violated 59 O.S. 1310(A)(2) and (28), by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondents that the Respondents are hereby FINED in the amount of \$1,000.00 each. The fines are to be paid to the Oklahoma Insurance Department no later than February 12, 2018.
