CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, and the Respondents, David Franklin Delozier and Curtis Pletcher, and enter into this Consent Order.

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent David Franklin Delozier ("Delozier") is a licensed bail bondsman in the State of Oklahoma holding license number 100202796. Delozier's address of record is 810 NW 6th Street, Oklahoma City, Oklahoma 73106-7241.
- 3. Respondent Curtis Pletcher ("Pletcher") is a professional bail bondsman in the state of Oklahoma holding license number 199574. Pletcher's address of record is P.O. Box 66, Springer, Oklahoma 73458-0066.

- 4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.
- 5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than \$250.00 nor more than \$2,500.00 for each occurrence.

STIPULATIONS OF FACT

6. On or about June 7, 2017, an appearance bond was executed as follows:

- 7. On or about August 4, 2017, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about August 4, 2017, by the Oklahoma County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Delozier and Pletcher with return receipt requested within 30 days after the Order's filing.
- 8. Delozier received a copy of the Order and Judgment of Forfeiture on August 10, 2017.
- 9. Pletcher received a copy of the Order and Judgment of Forfeiture on August 21, 2017.
- 10. The ninety-first day after receipt of the Order and Judgment of Forfeiture was November 9, 2017.

11. The forfeiture was not paid, and the defendant was not timely returned to custody.

CONCLUSIONS OF LAW

Defendant to custody within 90 days or remit payment in the face amount of the bond forfeiture within 91 days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41.

ORDER AND CONSENT

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondents that the Respondents are hereby FINED in the amount of \$250.00 each. The fines are to be paid to the Oklahoma Insurance Department no later than April 13, 2018, by money order or cashier's check.

IT IS FURTHER ORDERED that the face amount of the bond forfeiture shall be deposited with the Oklahoma County Court Clerk in Oklahoma County case number CF-2017-4431 should the court clerk show bond forfeiture as outstanding by April 13, 2018. If the forfeiture is not paid by April 13, 2018, the Oklahoma Insurance Department is ordered to withdraw the face amount of the bonds from Pletcher's professional bail bondsman certificate of deposit and forward it to the Oklahoma County Court Clerk for payment of the bond forfeitures.




