## ORDER OF LICENSE PROBATION

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Julie Meaders, and alleges and states as follows:

## **JURISDICTION**

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- 2. Alexander Sinclair Lewis is an applicant for a resident producer license. His address of record is 1544 NW 123<sup>rd</sup> Place, Oklahoma City, OK 73120.
- 3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code. 36 O.S. § 1435.13(A) and (D).

## FINDINGS OF FACT

1. Alexander Edwards applied for a producer license on January 2, 2018. The application asks the question "Have you ever been convicted of a crime, had a judgment withheld or deferred, or are you currently charged with committing a crime?" Edwards answered the question "yes".

- 2. If the question is answered "yes" the applicant must provide a written statement explaining the circumstances of the incident; a copy of the charging document; and a copy of the official document demonstrating resolution of the charges or any final judgment.
- 3. Edwards complied by submitting the Information in Oklahoma County Case No. CF-2016-9042 and an explanation concerning why he is currently charged with felonies.

# CONCLUSIONS OF LAW

Edwards is currently charged with felony crimes. The Insurance Commissioner may place a new licensee on probation pending the final resolution of criminal charges. 36 O.S. § 1435.13(A).

## **ORDER**

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that Edwards is granted a producer license on a probationary status pending resolution of his felony charges. Edwards is to immediately report the outcome of his case upon final adjudication. The status of his probationary license will be reevaluated at that time.
