STIPULATION AND AGREED ORDER

COMES NOW Sandra LaVenue, Senior Counsel for the Oklahoma Insurance Department ("OID"), and Fredrick Clark Holder ("Holder"), who stipulate and agree to the following findings of fact and conclusions of law.

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1341.
- Respondent Holder is a professional ball bondsman in the state of Oklahoma holding license number 199639.
- 3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. § 1310.

AGREED FINDINGS OF FACT

On or about June 28, 2017, appearance bonds were executed as follows:

- 5. On October 16, 2017, the Defendant failed to appear and the court issued bench warrants and bonds were declared forfeited. Orders and Judgments of Forfeiture were also issued and filed in the cases on October 16, 2017, by the Comanche County District Court. A true and correct copy of the Orders and Judgments of Forfeiture were mailed to Carstensen and Nelson at their addresses of record on file with the Oklahoma Insurance Department with return receipt requested within thirty (30) days after the Order's filing.
- Both Carstensen and Holder received copies of the Orders and Judgments of Forfeiture on October 18, 2017.
- 7. The ninety-first (91") day after receipt of the Orders and Judgments of forfeiture was January, 18, 2018.
- 8. The forfeitures were paid on or about April 10, 2018, which was past the date that the forfeiture was due.
 - Respondent Holder voluntarily submits to the jurisdiction of OID without a

hearing and enters into this Stipulation and Agreed Order.

Respondent Holder acknowledges the above stipulations of fact and the 10. agreed conclusions of law and agrees to pay an administrative fine in the amount of Two Hundred and Fifty Dollars (\$250.00).

AGREED CONCLUSIONS OF LAW

- Respondent Holder has violated 59 O.S. § 1310(A)(2) and (28) by 11. violating the provisions of 59 O.S. § 1332 and by failing to pay fees due to a district court clerk as required by the Oklahoma Bail Bond Act, 59 O.S. § 1301-1341.
- Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the 12. Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a fine of not less than \$250.00 but not more than \$2,500.00 per violation.

AGREED ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner, and CONSENTED TO by Respondent Holder that Respondent Holder is assessed an administrative fine in the amount of Two Hundred and Fifty Dollars (\$250.00), which is due upon entry of this Agreed Order.
