CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel, Julie Meaders, and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent, Shawn McClanahan, is a licensed bail bondsman in the State of Oklahoma holding license number 199851. His address of record is P.O. Box 104, Oklahoma City, Oklahoma 73101.
- 3. Respondent, Howard McClanahan, is a multi-county bail bondsman in the state of Oklahoma holding license number 199770. His address of record is P.O. Box 1631, Idabel,

Oklahoma 774745-1631.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.

ALLEGATIONS OF FACT

5. On or about August 2, 2017, an appearance bond was executed as follows:

- 6. On October 4, 2017, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on October 13, 2017 by the Oklahoma County Court Clerk. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Shawn McClanahan and Howard McClanahan with return receipts requested within thirty (30) days after the Order's filing.
- 7. Shawn McClanahan received a copy of the Order and Judgment of Forfeiture on October 23, 2017.
- 8. Howard McClanahan received a copy of the Order and Judgment of Forfeiture on October 23, 2017.
- 9. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was January 22, 2018.
 - 10. The forfeiture was paid on January 23, 2018.

ALLEGED VIOLATIONS OF LAW

11. Respondents have violated 59 O.S. §§ 1310(A)(2) and 1332 by failing to return

the Defendant to custody or remit payment in the face amount of the bond forfeiture by January 22, 2018.

12. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1340, may be subject to a fine of not less than \$250 but not more than \$2,500 per violation.

<u>ORDER</u>

IT IS THEREFORE ORDERED that Shawn McClanahan and Howard McClanahan are each FINED TWO HUNDRED AND FIFTY DOLLARS (\$250.00). The fines are to be paid within thirty (30) days of the date of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department. If the fines are not paid within thirty (30) days of the date of this Order, Respondents' respective licenses will be suspended and shall remain suspended until the fines are paid in full.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless either the bondsman or professional request a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of this Conditional Order, the penalties set forth above shall become a Final Order on the thirty-first (31st) day following the date of mailing this Order.

A request for hearing should be in writing and addressed to Julie Meaders, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order and shall be served on the Oklahoma Insurance Department within the thirty (30) days allotted. The proceedings on such requested hearing will be conducted in accordance with the

Oklahoma Insurance Code, 36 O.S. §§ 101 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 et seq.

If either the bondsman or the professional serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as a notice of the matters to be reviewed at the hearing and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.
