4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to *59 O.S. §§ 1310 and 1332*.

**ALLEGATIONS OF FACT**

5. On or about March 4, 2017 an appearance bond was executed as follows:

Defendant:	Kyle Wayne Pugh
Case Number(s):	CF-2017-105
City/County:	Osage County
Surety:	Curtis Pletcher
Bondsman:	Ryanne Hamilton
Power Number(s):	114552
Bond Amount(s):	\$5,000.00

6. On April 20, 2017, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on May 1, 2017 by the Osage County Court Clerk. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Hamilton and Pletcher with return receipts requested within thirty (30) days after the Order's filing.

7. Ryanne Hamilton failed to claim her copy of the Order and Judgment of Forfeiture and it was returned to Osage County on May 27, 2017.

8. Curtis Pletcher received a copy of the Order and Judgment of Forfeiture on May 4, 2017.

9. Two Motions for Additional Time were granted making the ninety-first (91<sup>st</sup>) day to pay the forfeiture January 29, 2018.

10. The forfeiture remains unpaid.

**ALLEGED VIOLATIONS OF LAW**

11. Respondents have violated *59 O.S. §§ 1310(A)(2) and 1332* by failing to return

the Defendant to custody or remit payment in the face amount of the bond forfeiture by January 29, 2018.

12. Pursuant to *59 O.S. § 1310(B)*, any bondsman violating a provision of the Bail Bond Act, *59 O.S. §§ 1301-1340*, may be subject to a fine of not less than \$250 but not more than \$2,500 per violation.

### **ORDER**

**IT IS THEREFORE ORDERED that Ryanne Hamilton and Curtis Pletcher are each FINED FIVE HUNDRED DOLLARS (\$500.00).** The fines are to be paid within thirty (30) days of the date of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department. If the fines are not paid within thirty (30) days of the date of this Order, Respondents' respective licenses will be suspended and shall remain suspended until the fines are paid in full.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner that this Order is a Conditional Order. Unless either the bondsman or multi-county bail bondsman request a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of this Conditional Order, the penalties set forth above shall become a Final Order on the thirty-first (31<sup>st</sup>) day following the date of mailing this Order.

A request for hearing should be in writing and addressed to Julie Meaders, Oklahoma Insurance Department, Legal Division, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order and shall be served on the Oklahoma Insurance Department within the thirty (30) days allotted. The proceedings on such requested hearing will be conducted in accordance with the

Oklahoma Insurance Code, 36 O.S. §§ 101 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 et seq.

If either the bondsman or the multi-county bail bondsman serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order shall act as a notice of the matters to be reviewed at the hearing and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.


