CONDITIONAL ORDER AND NOTICE OF HEARING AND ORDER TO SHOW CAUSE

Respondent.

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel, Sara A. Worten, and alleges and states as follows:

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1341.
- 2. Respondent Jamie Don Parker ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 100280555. Respondent's mailing address of record with the Oklahoma Insurance Department is 110 N. Vann Street, Pryor, Oklahoma.
- 3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. § 1310.

ALLEGATIONS OF FACT

- 4. Pursuant to 59 O.S. § 1314(B) and OAC 365:25-5-36(a), every licensed bondsman shall electronically submit monthly reports by the fifteenth day of each month.
 - 5. Respondent is licensed as a surety bondsman, but does not currently hold a surety

appointment. As such, he must file a monthly "No Surety" report.

- 6. Respondent has failed to submit his No Surety report for January 2018, February 2018, and March 2018.
- 7. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310.
- 8. Pursuant to 59 O.S. § 1310(A), the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued under Sections 1301 through 1341 for any of the following causes:
 - 2. Violation of any laws of this state or any lawful rule, regulation, or order of the Commissioner relating to bail;
 - 24. For failing to file a report as required by Section 1314 of tile 59.
- 9. Pursuant to 59 O.S. § 1310(B), in addition to any denial, censure, suspension, or revocation of a license, any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a civil penalty of not less than \$250.00 but not more than \$2,500.00 per violation.

CONCLUSIONS OF LAW

10. Respondent has violated 59 O.S. § 1310(A)(2) and (24), on 3 occasions by failing to file his monthly reports by the fifteenth day of the following month in accordance with the provisions of 59 O.S. § 1314(B).

ORDER

IT IS THEREFORE ORDERED that Respondent Jamie Don Parker is **CENSURED** for violations of the Bail Bond Act.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing

with respect to the Allegations of Fact set forth above within 30 days of the date of mailing of this Order, this Order and the penalties set forth above will become a Final Order on the thirtyfirst day following the date of mailing this Order. A request for hearing should be in writing addressed to Sara A. Worten, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing will be conducted according to the procedures for contested cases under the Oklahoma Bail Bond Act and 75 O.S. § 250-323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order will act as notice of the matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order will be considered withdrawn, pending final resolution at the hearing.
