ORDER LIFTING SUSPENSION

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through his attorney, Sara A. Worten, and alleges and states as follows:

1. On June 19, 2018, a Conditional Administrative Order and Notice of Right to be Heard was issued. Lesa Woodard ("Respondent") was fined Two Hundred Fifty Dollars (\$250.00). The fine was to be paid within thirty (30) days of receipt of the Order or Respondent could request a hearing in the same amount of time. If the fine was not paid within the time allowed and a hearing was not requested, her bail bond license would be suspended.

2. Respondent failed to pick up the June 19, 2018 Order, which was mailed by certified mail to her at 217 N Harvey Ave. #206A, Oklahoma City, Oklahoma 73102-3803. Said Order was returned by the United States Postal Service ("USPS) on June 26, 2018 and marked "Moved Left No Address/Unable to Forward/Return to Sender."

3. The June 19, 2018 Order was again mailed to Respondent. On June 27, 2018, it was mailed to Respondent's home address, 4641 SE 21st, Oklahoma City, Oklahoma 73115.

4. The June 27, 2018 mailing of the Order was returned to Petitioner, marked "Return to Sender/UNCLAIMED/Unable to Forward" on July 24, 2018.

5. As of July 26, 2018, the fine had not been paid nor had Respondent submitted a request for hearing. Pursuant to the terms of the Conditional Order, Respondent's license was suspended. Notification was sent to the Oklahoma County Court Clerk and Oklahoma City Municipal Court Clerk's office regarding the suspension.

6. On August 2, 2018, the fine was paid.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that suspension of Lesa Woodard's bail bond license is hereby lifted.
