CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. John Doak, Insurance Commissioner, and the Respondent, Paul W. Meade Insurance Agency, Inc. ("Respondent") and stipulate to the following facts and applicable laws. The parties consent to the entry of this Order.

JURISDICTION

- John Doak is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- 2. Respondent is a resident Oklahoma insurance producer holding license 12916. Its address of record is 4220 N. Classen Boulevard, Oklahoma City, Oklahoma 73118.
- 3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer

Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code, 36 O.S. § 1435.13(A) and (D).

4. Informal disposition of this matter may be made by consent order pursuant to 75 O.S. § 309(E).

STIPULATIONS OF FACT

- Respondent Paul W. Meade Insurance Agency, Inc. submitted an application to reinstate its producer license on July 30, 2018.
- 2. Oklahoma Insurance Department records show that Respondent's license expired on May 31, 2017 for failing to renew.
- During the time Respondent's license was expired, it sold approximately
 Oklahoma policies in the state of Oklahoma.
- 4. Respondent is required to maintain an active license while conducting an insurance business in Oklahoma.

CONCLUSIONS OF LAW

1. Respondent violated 36 O.S. § 1435.4(A) in failing to maintain an active producer license in Oklahoma while conducting insurance-related business, thereby in violation of 36 O.S. § 1435.13(A)(2).

ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that it shall be and hereby is fined in the amount of \$500.00. The fine is to be paid immediately. Upon payment of the fine Respondent's producer license will be reinstated.
