CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

JURISDICTION

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1341.
- 2. Respondent Rebecca Sypert ("Sypert") is a licensed bail bondsman in the State of Oklahoma holding License Number 40072176.
- 3. Respondent Bonnie Galmor ("Galmor") is a multicounty agent bail bondsman in the State of Oklahoma holding License Number 200305.
- 4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. § 1310.

- 5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.
- 6. If either Respondent requests a hearing in writing in this matter, pursuant to *OAC* 365:1-7-1, the Insurance Commissioner, pursuant to 59 O.S. § 1311.1, will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondent.
- 7. The Insurance Commissioner, pursuant to *OAC 365:1-7-5*, upon written request reasonably made by a person affected by the hearing and at such person's expense, shall cause a full stenographic record of the proceedings to be made by a competent court reporter.

ALLEGATIONS OF FACT

8. On or about April 25, 2017, an appearance bond was executed as follows:

9. On May 10, 2018, the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued and filed in the case on May 14, 2018, by the Logan County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Sypert and Galmor at their address of record on file with the Oklahoma Insurance Department with return receipt requested within thirty (30) days after the Order's

filing.

- The copy of the <u>Order and Judgment of Forfeiture</u> sent to Sypert by certified mail at the address of record was returned to the Logan County District Court as unclaimed.
- 11. Galmor received a copy of the <u>Order and Judgment of Forfeiture</u> on May 16, 2018.
- 12. The ninety-first (91st) day after receipt of the <u>Order and Judgment of Forfeiture</u> was Wednesday, August 15, 2018.
 - 13. The forfeiture was paid untimely on August 20, 2018.

ALLEGED VIOLATIONS OF LAW

- 14. Respondents Sypert and Galmor have violated 59 O.S. § 1310(A)(2) and (28) by violating the provisions of 59 O.S. § 1332 and by failing to pay fees due to a district court clerk as required by the Oklahoma Bail Bond Act, 59 O.S. § 1301-1341.
- 15. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a fine of not less than \$250.00 but not more than \$2,500.00 per violation.

ORDER

Hundred and Fifty Dollars (\$250.00). The fines are to be paid within thirty (30) days of the date of this Conditional Administrative Order and Notice of Right to Be Heard and made payable to the Oklahoma Insurance Department. If the fines are not paid or a hearing requested within thirty (30) days, the Oklahoma Insurance Department may initiate further administrative action.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless either Sypert or Galmor requests a hearing with respect to the Allegations of Fact set forth above within thirty (30) days of the date of this Conditional Administrative Order and Notice of Right to Be Heard, the penalties set forth above shall become a Final Order on the thirty-first (31st) day following the date of mailing this Order. A request for hearing should be in writing and addressed to Brian C. Chandler, Staff Counsel, Legal Division, Oklahoma Insurance Department, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order and shall be served on the Oklahoma Insurance Department within the thirty (30) days allotted. The proceedings on such requested hearing will be conducted in accordance with the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.; the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250-324 and the Oklahoma Bail Bond Act, 59 O.S. §§ 1301-1341. If either Sypert or Galmor serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Administrative Order and Notice of Right to Be Heard shall act as a notice of the matters to be reviewed at the hearing and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Administrative Order and Notice of Right to Be Heard shall be considered withdrawn, pending final resolution at the hearing.
