**FINAL ADMINISTRATIVE ORDER**

This matter is a proceeding under the Oklahoma Bail Bond Code, 59 O.S. §§ 1301 et seq., the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., and conducted pursuant the Oklahoma Administrative Procedures Act, 75 O.S. §§ 301 et seq, whereby Respondent, Chauncey Summers (“Respondent”) is an Oklahoma licensed bail bondsman in the state of Oklahoma holding license number 40041039. On October 2, 2018, the Oklahoma Insurance Department (“OID”) issued a Notice of Hearing and Order to Show Cause, alleging violations of the provisions of Title 59 of the Oklahoma Statutes and setting this matter for hearing on October 23, 2018, at 10:00 a.m. at the office of the Oklahoma Insurance Department, 3625 N.W. 56<sup>th</sup> Street, Suite 100, Oklahoma City, Oklahoma. Legal service of summons was sent to Respondent to his mailing address on file with the OID to which it was returned as unclaimed. Legal service of summons was achieved by serving Respondent in person by OID Investigator, Stephen Colburn, on October 12, 2018.

On October 23, 2018, the above captioned case came on for hearing at OID and testimony and evidence was received at that time. Oklahoma Insurance Commissioner John D. Doak appointed the undersigned independent Hearing Examiner, John D. Miller, to preside at the

hearing as a quasi-judicial officer pursuant to *59 O.S. § 1311.1(B)*. The hearing was recorded electronically by employees of the Oklahoma Insurance Department (“OID”). Petitioner was represented by Assistant General Counsel, Sara A. Worten. Respondent did not appear at the hearing. Testimony and evidence was heard before the undersigned Hearing Examiner. Therefore, after consideration of the testimony and evidence presented, this independent Hearing Examiner issues his order of findings and conclusions of law.

### **FINDINGS OF FACT**

1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, *36 O.S. §§ 101-7401*, and the Oklahoma Bail Bond Act, *59 O. S. §§ 1301-1341*.

2. Respondent Chauncey Summers (“Respondent”) is a licensed bail bondsman in the State of Oklahoma holding license number 40041039. Respondent’s mailing address of record with the Oklahoma Insurance Department is Post Office Box 851, Tulsa, Oklahoma.

3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to *59 O.S. § 1310*.

4. The Insurance Commissioner, pursuant to *59 O.S. § 1311.1(B)*, appointed an independent Hearing Examiner and that Hearing Examiner has the jurisdiction to determine if there is evidence to support a finding by clear and convincing evidence that Respondent’s actions as alleged in the OID Notice of Hearing and Order for Show Cause issued on October 2, 2018, were established by the evidence and were in violation of the Oklahoma Bail Bond Code.

5. The hearing was recorded electronically by an employee of the Oklahoma Insurance Department. Neither party requested a full stenographic record of the proceedings.

6. Lewis Garrison, Director of the OID's Bail Bond Division, was sworn and testified under oath.

7. Respondent no longer has surety appointments so instead of filing a Surety Report he must file a No Surety Report.

8. Respondent failed to submit his May 2018 report which was due no later than June 15, 2018.

9. Respondent failed to submit his June 2018 report which was due no later than July 16, 2018.

10. Respondent failed to submit his July 2018 report which was due no later than August 15, 2018.

11. Respondent failed to submit his August 2018 report which was due no later than September 17, 2018.

12. The Department contacted Respondent regarding the failure to submit the reports. Respondent did not respond to the Department.

#### **CONCLUSIONS OF LAW**

13. Respondent has violated *59 O.S. § 1310(A)(2) and (24)*, on four occasions by failing to file his monthly reports by the fifteenth day of the following month in accordance with the provisions of *59 O.S. § 1314(B and OAC 365:25-5-36)*.

#### **ORDER**

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that it has been established by clear and convincing evidence that Respondent Chauncey Summers violated *59 O.S. § 1310(A)(2) and (24)*, of the Oklahoma Bail Bond Code by failing to timely file**


reports with the Oklahoma Insurance Department and as a result Respondent Chauncey Summers' bail bondsmen license is REVOKED.

IT IS FURTHER ORDERED that Respondent is FINED \$500.00 to be paid to the Oklahoma Insurance Department within 30 days of receipt of this order.

IT IS FURTHER ORDERED that Respondent is assessed the costs of this matter in the amount of \$131.67 to be paid to the Oklahoma Insurance Department within 30 days of receipt of this order.
