To complete this change in the state of Oklahoma, the Company will need to file the following to the Oklahoma Insurance Department:
File Electronically through the NAIC's Corporate Amendment Portal:
UCAA Form 2C Corporate Amendment Application.
Certified State Insurance Department approval for redomestication from both the former and the new state of domicile.
Certified Certificate of Deposit from the new domicile state.
Certified amended/restated Articles of Incorporation (Fee \$50.00). <i>If applicable.</i>
Certified amended/restated Bylaws (Fee \$50.00). <i>If applicable.</i>
File Electronically through the <u>NAIC's Corporate Amendment Portal</u> under "Contact Information":
UCAA Form 14 Change of Address/Contact Notification. Initial filing required, amendments if applicable.
<mark>File by mail</mark> to the Oklahoma Insurance Department, <mark>Financial Division</mark> , 400 NE 50th St. Oklahoma City, OK 73105:
Surrender the current Certificate of Authority for amendment (must be original or the UCAA Form 15 Affidavit of Lost Certificate of Authority) – no fee.
Fees: Mail the check with a cover letter and the Certificate of Authority (or Form 15). Checks must be payable to the OKLAHOMA INSURANCE DEPARTMENT and arrive with paperwork to assure the payment can be applied properly. Note: All fees noted above apply unless the retaliatory fee is higher pursuant to Title 36 O.S. § 628.

UCAA Form 12 Consent for Service of Process. <i>If applicable.</i> Mail the Form 12 with a check in the amount of \$10, payable to the Oklahoma Insurance Department.
