# FINAL ADMINISTRATIVE ORDER

This matter is a disciplinary proceeding under the Oklahoma Bail Bond Act, 59 O.S. §§ 1301 et seq., and conducted pursuant to the Oklahoma Administrative Procedures Act, 75 O.S. §§ 301 et seq. On January 15, 2019, the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner (the "Petitioner"), issued a Notice of Hearing and Order for Show Cause (the "Notice") alleging that Ryanne Christine Hamilton (the "Respondent") violated provisions of the Code and setting this matter for hearing on February 6, 2019, at 9:30 a.m. at the office of the Oklahoma Insurance Department ("OID"), 3625 N.W. 56th Street, Suite 100, Oklahoma City, Oklahoma. Respondent received the Notice through certified mail on January 17, 2019. Respondent requested a continuance, which was set for March 14, 2019, at 9:30 a.m.

The administrative hearing was held before the undersigned Hearing Examiner on March 14, 2019. Petitioner appeared by counsel, Teresa L. Green. Respondent appeared pro se. Witnesses for Petitioner, OID Director of Bail Bonds Division Lewis Garrison and Legal Assistant Sherry Standerfer, and Respondent were sworn and testified. Exhibits were presented and arguments heard.

# **JURISDICTION**

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., and the Oklahoma Bail Bond Act (the "Act"), 59 O.S. §§ 1301 et seq..
- 2. Respondent is a previously licensed bail bondsman in the State of Oklahoma holding license number 40088144. Respondent's mailing address of record is 6236 N. Troost Ave., Tulsa, OK 74126-1710.
- 3. Pursuant to 59 O.S. § 1310(A)(3), the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued under Sections 1301 through 1341 for "[m]aterial misstatement, misrepresentation, or fraud in obtaining the license."
- 4. Pursuant to 59 O.S. § 1310(B), in addition to any denial, censure, suspension, or revocation of a license, any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301-1341, may be subject to a civil penalty of not less than \$250.00 but not more than \$2,500.00 per violation.
- 5. The Insurance Commissioner, pursuant to 59 O.S. § 1311.1(B), appointed the undersigned Independent Hearing Examiner to sit as a quasi-judicial officer over the above cause.

# **FINDINGS OF FACT**

- 6. On or about October 26, 2018, Respondent submitted a renewal application for her bail bondsman license.
  - 7. On the Oklahoma application form, question 2 asks the following:

    Have you ever been named or involved as a party in an administrative proceeding, including FINRA sanction or

arbitration proceedings regarding any professional or occupational license or registration? "Involved" means having a license censured, suspended, revoked, canceled, terminated; or, being assessed a fine, a cease and desist order, a prohibition order, a compliance order, placed on probation, sanctioned or surrendering a license to resolve an administrative action. "Involved" also means being named as a party to an administrative or arbitration proceeding, which is related to a professional or occupational license, or registration. "Involved" also means having a license, or registration application denied or the act of withdrawing an application to avoid a denial. INCLUDE Any business so named because of your actions in your capacity as an owner, partner, officer or director, or member or manager of a Limited Liability Company. You may EXCLUDE terminations due solely to noncompliance with continuing education requirements or failure to pay a renewal fee.

Respondent answered "No" to this question.

- 8. The Oklahoma Insurance Department ("OID") discovered the following administrative proceedings:

- 9. Respondent has been fined a total of Five Thousand Nine Hundred Dollars (\$5,900.00) and censured three (3) times for the above administrative actions.
  - 10. On or about October 26, 2019, OID requested a written explanation for answering

"No" despite each of the above administrative proceedings in Oklahoma.

- 11. On or about October 29, 2019, Respondent explained that she did "not understand what an FINRA was....I did not think FINRA applied to OID and a Bailbond License." Respondent described nine (9) as "miscommunication," one (1) as being "punished for a Clerks error," and three (3) as calendaring issues as well as other issues with Defendant names and "assuming...permission to file...late."
- 12. On or about December 10, 2018, OID denied Respondent's application for a bail bond license for "material misstatement, misrepresentation, or fraud in obtaining the license."
- 13. On or about January 7, 2019, OID received a written request from Respondent for a hearing regarding the denial of her license. In her written request, Respondent further states that OID's question is "nothing like the question" in the "renewal section of NIPR" that "does not specify OID, State of Oklahoma or Bail []Bonds."
- 14. The Insurance Commissioner appointed John D. Miller to hear the case as the independent hearing examiner.
- 15. The hearing was recorded electronically by employees of the OID. Neither party requested a full stenographic record of the proceedings.

- 17. Lewis Garrison, Sherry Standerfer, and Respondent were sworn and testified to the above findings of facts under oath.

### **CONCLUSIONS OF LAW**

18. Respondent violated 59 O.S. 1310(A)(3), by providing a material misstatement, misrepresentation, or fraud in obtaining the license when she answered "No" to being named in

any administrative proceedings despite sixteen (16) administrative actions by OID naming Respondent as a party.

# **ORDER**

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED that it has been established by clear and convincing evidence that Respondent Ryanne Christine Hamilton violated 59 O.S. 1310(A)(3) and, as a result, the OID denial of Respondent's bail bondsman license is upheld. Respondent's bail bondsman license in the State of Oklahoma is hereby **DENIED**.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that any and all fines related to this matter are hereby waived. However, Respondent shall <u>pay</u> the costs of the administrative hearing in the amount of one hundred thirty-eight dollars and forty cents (\$138.40). All costs shall be paid within thirty (30) days made payable to the Oklahoma Insurance Department. The costs shall be paid by money order or cashier's check.
