### CONSENT ORDER

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, and the Respondent, Lindsay Marie Cordell, ("Respondent") and stipulate to the following facts and applicable laws. The parties consent to the entry of this Order.

#### **JURISDICTION**

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- Respondent is a resident Oklahoma insurance producer holding Oklahoma license number 100130309, with an address of record as 1124 Bridgeview Lane, Tuttle, OK 73089-3129,

- 3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Insurance Producers Licensing Act or may levy a civil fine of not less than One Hundred Dollars (\$100.00) nor more than One Thousand Dollars (\$1,000.00) for each occurrence pursuant to 36 O.S. §1435.13.
- 4. Respondent, has been offered the opportunity for a hearing pursuant to the Oklahoma Insurance Code, 75 O.S. § 309 and has waived the right for a hearing.
- 5. Informal disposition of this matter may be made by consent order pursuant to 75 O.S. § 309(É).

### STIPULATIONS OF FACT

1. Respondent, Lindsay Marie Cordell was provided notification of concerns regarding the Oklahoma Insurance Code, 36 O.S. §1435.13 A.8, "Using information which was not diligently reviewed regarding an address on a claim for her father's roof and not researching properly the submission of invoices of one Jose Rodriguez.

### CONCLUSIONS OF LAW

1. Respondent violated 36 O.S. § 1435.13 A.8. only in demonstrating insufficiency of due diligence in business activities, which ultimately created no harm to the insured or any insurance company.

#### ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner and CONSENTED to by the Respondent that it shall be and hereby is CENSURED for the afore described violation.
