**CONDITIONAL ADMINISTRATIVE ORDER**  
**AND NOTICE OF RIGHT TO BE HEARD**

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner,  
by and through his counsel, Ron Kreiter, and alleges and states as follows:

**JURISDICTION AND AUTHORITY**

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma ("Commissioner") and administers and enforces the Oklahoma Bail Bond Act, 59 O.S. § 1301-1341. The Commissioner is the chief executive officer of the Oklahoma Insurance Department. 36 O.S. § 301 et.seq.
2. The Commissioner has jurisdiction over the subject matter and in this administrative action and may issue penalties pursuant to 59 O.S. § 1310.
3. Christopher Ryan Gallimore ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license number 100229053, and respondent's mailing address of record with the Department is 600 SW 37<sup>th</sup> Street, Moore, OK 73160-7744.
4. Respondent is a licensed bail bondsman, and therefore, a monthly report is due. 59 O.S. §§ 1310 (A) (24) and 1314 (B).
5. In addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence of a violation. 59 O.S. § 1310 (B)
6. In the event that the Respondent requests a hearing in writing in this matter, the Commissioner shall appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing. 59 O.S. § 1311.1 OK Admin. Code § 365:1-7-1.

7. Upon written request, reasonably made by a person affected by the hearing and at such person's expense, the Commissioner shall cause a full stenographic record of the proceedings to be made by a competent court reporter. OK Admin. Code § 135:1-7-5.

#### **PROPOSED FINDINGS OF FACT**

8. Respondent failed to timely submit his April 2019 NOSURETY bond report no later than May 15, 2019. He has not filed that report.
9. Respondent failed to timely submit his May, 2019 NOSURETY bond report no later than June 17, 2019. He has not filed his report.

#### **PROPOSED CONCLUSIONS OF LAW**

10. Respondent has violated 59 O.S. § 1310 (A) (24) by failing to timely file monthly reports as required by 59 O.S. § 1314.

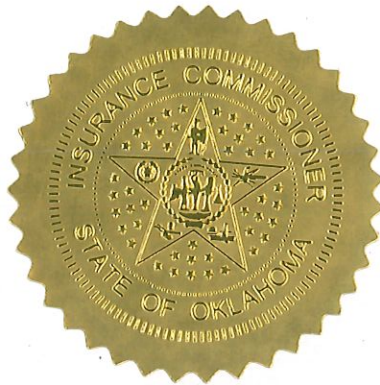
#### **ORDER**

**IT IS THEREFORE ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner, subject to the following paragraph, that the Respondent violated the provisions of 59 O.S. §§ 1310 (A) (24) and 1314, by failing to file monthly reports and it is hereby fined Two Hundred and Fifty Dollars (\$250.00) for each occurrence for a total fine of Five Hundred Dollars (\$500.00). The civil fine shall be paid within thirty (30) days receipt of this conditional administrative order by Respondent and made payable to the Oklahoma Insurance Department. Subject to the following paragraph, failure to timely pay the civil fine may result in further administrative action.


**IT IS THEREFORE FURTHER ORDERED, ADJUDGED AND DECREED** by the Insurance Commissioner that this order is a conditional administrative order. Unless Respondent requests a hearing with respect to the proposed findings of fact and proposed conclusions of law set forth above within thirty (30) days of receipt of this conditional administrative order by the Respondent, this conditional order and the penalties set forth above shall become a final administrative order on the thirty first (31<sup>st</sup>) day following receipt of this conditional administrative order by Respondent. Such request for hearing, if desired, shall be in writing, addressed to Ron Kreiter, Deputy General Counsel, Oklahoma Insurance Department, 3625 NW 56<sup>th</sup> St., Suite 100, Oklahoma City, OK 73112, and shall state the basis for requesting the hearing. The request shall be served on the Oklahoma Insurance Department within thirty (30) days required. The proceedings on such requested hearing will be conducted in accordance to the Oklahoma Bail Bond Act, 59 O.S. §§1301-1341, and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250-403. If respondent serves a timely request for hearing on the Oklahoma Insurance Department, this conditional administrative order shall act as notice of the matters to be reviewed at the hearing and the proposed findings of fact, proposed conclusions of law, penalties imposed herein shall be considered withdrawn, pending final resolution at the hearing.


