CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through his counsel, Teresa L. Green, and alleges and states as follows:

JURISDICTION

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., including the Oklahoma Insurance Adjusters Licensing Act, 36 O.S. §§ 6201 et seq.
- 2. Respondent Angela Renay Carlson ("Respondent") is an applicant for a renewal nonresident adjuster license, license number 132979. Respondent's mailing address of record is 421 Misty Meadow Dr., Allen, TX 75013-3473.
- 3. The Insurance Commissioner may censure, suspend, revoke, or refuse to issue or renew a license pursuant to the Oklahoma Insurance Adjusters Licensing Act or may subject to a civil fine of not more than \$1,000.00 for each violation. See 36 O.S. §§ 6220(A) and (B).

4. The Oklahoma Insurance Department shall retain the authority to enforce the provisions of and impose any penalty or remedy authorized by this title against any person who is under investigation for or charged with a violation even if the person's license or registration has been surrendered or has lapsed by operation of law. See 36 O.S. § 6220(E).

FINDINGS OF FACT

- 5. On or about December 31, 2018, Respondent's adjuster license for the State of Oklahoma expired.
- 6. From approximately January 1, 2019 to August 21, 2019, Respondent adjusted fifteen (15) claims in Oklahoma for CNA.
- 7. As a result, these fifteen (15) claims were adjusted by Respondent while her license was expired.
- 8. The Insurance Commissioner may subject any person violating the provisions of the Insurance Adjusters Licensing Act to civil fines of not more than \$1,000 for each violation. See 36 O.S. §§ 6220(A)–(B).
- 9. Pursuant to the Insurance Adjuster Licensing Act, an adjuster shall have authority in accordance with his or her license only to investigate or report to his or her principal upon claims on behalf of the insurers if the adjuster is licensed as an insurance adjuster, or on behalf of the insured if licensed as a public adjuster. See 36 O.S. § 6216(A). See also 36 O.S. § 6220(A)(9) (providing authority to discipline a person for "[a]djusting losses or negotiating claim settlements arising pursuant to provisions of insurance contracts on behalf of an insurer or insured without proper licensing from the Commissioner").

CONCLUSIONS OF LAW

10. Respondent violated 36 O.S. § 6220(A)(9) by adjusting losses or negotiating claim settlements arising pursuant to provisions of insurance contract on behalf of an insurer or insured without proper licensing from the Commissioner when Respondent adjusted fifteen (15) claims in Oklahoma from January 1, 2019 to August 21, 2019 for CNA without an adjuster license.

ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner that Respondent is hereby **fined ONE HUNDRED DOLLARS** (\$100.00) for violation of 36 O.S. § 6220(A)(9). The fine shall be paid within **thirty** (30) **days** made payable to the Oklahoma Insurance Department by money order or cashier's check.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless the Respondent requests a hearing with respect to the Findings of Fact set forth above within thirty (30) days of the date of mailing of this Order, this Order and the penalties set forth above will become a Final Order on the thirty-first (31st) day following the date of mailing this Order. A request for hearing should be in writing addressed to Teresa L. Green, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing will be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250–323. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order will act as notice of the matters to be reviewed at the hearing, and the Findings of Fact, Conclusions of Law, and

penalties imposed in this Conditional Order will be considered withdrawn, pending final resolution at the hearing.
