CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Teresa L. Green, and alleges and states as follows:

JURISDICTION

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Lloyd Newman Simmons ("Respondent Simmons") is a licensed bail bondsman in the State of Oklahoma holding license number 100285456. Respondent Simmons's address of record is P.O. Box 211, Foss, OK 73647-0211.
- 3. Respondent Dennis Lloyal Berglan ("Respondent Berglan") is a multicounty agent bondsman in the state of Oklahoma holding license number 199413.

Berglan's address of record is 1945 Exchange Ave., Oklahoma City, OK 73108-2821.

4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.

5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure,

suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act

may be subject to a civil penalty of not less than \$250.00 nor more than \$2,500.00 for each

occurrence.

6. If Respondents request a hearing in writing in this matter, pursuant to OAC 365:1-

7-1, the Insurance Commissioner, pursuant to 59 O.S. § 1311.1, will appoint an independent

hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested

by Respondent.

7. The Insurance Commissioner, pursuant to OAC 365:1-7-5, upon written request

reasonably made by a person affected by the hearing and at such person's expense, shall cause a

full stenographic record of the proceedings to be made by a competent court reporter.

FINDINGS OF FACT

8. On or about March 12, 2018, an appearance bond was executed as follows:

10. On or about January 17, 2019, the Defendant failed to appear in both cases and the bonds were declared forfeited. An Order and Judgment of Forfeiture was issued in both cases on or about January 16, 2019, by the Beckham County District Court. A true and correct copy of both Order and Judgment of Forfeiture was mailed to Respondent Simmons and Respondent Berglan with return receipt requested within thirty (30) days after the Order's filing.

- 11. Respondent Simmons received both copies of the Order and Judgment of Forfeiture on or about January 31, 2019.
- 12. Respondent Berglan received both copies of the Order and Judgment of Forfeiture on or about January 23, 2019.
- 13. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture was May 2, 2019.
- 14. On or about April 24, 2019, the Beckham County Court granted an extension in both cases to produce defendant or pay amount due by July 29, 2019.
- 15. As of this date, the forfeiture has not been paid nor the Defendant returned to custody.

CONCLUSIONS OF LAW

- 16. Respondents have violated 59 O.S. 1310(A)(2) and (28), by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within ninety-one (91) days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41 by failing to return Paul Lamb to custody or pay the forfeiture in either CF-2015-324 or CM-2018-54 in Beckham County, Oklahoma.
- 17. Pursuant to 59 O.S. § 1310(B), any bondsman violating a provision of the Bail Bond Act, 59 O.S. §§ 1301 et seq., may be subject to a fine of not less than \$250.00 but not more than \$2,500.00 per violation.

ORDER

IT IS THEREFORE ORDERED that Respondent Simmons and Respondent Berglan are each FINED \$250.00 per violation, for a total fine of \$500.00 due from each Respondent. The fines are to be paid within thirty (30) days of the date of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department. Payment is to be made by either cashier's check or money order. If the fines are not paid within thirty (30) days, Respondents' respective licenses will be suspended and shall remain suspended until the fines are paid in full.

IT IS FURTHER ORDERED that Respondent Berglan is to pay the forfeitures in Beckham County District Court Case (1) CF-2015-324, State of Oklahoma v. Paul Michael Lamb, and (2) CM-2018-54, State of Oklahoma v. Paul Michael Lamb. If the forfeitures are not paid within thirty (30) days from receipt of this Order, pursuant to 59 O.S. §§ 1306.1(B) and 1332(D)(4)(b), the Oklahoma Insurance Department shall withdraw the face amount of the

bonds, Three Thousand Dollars (\$3,000.00) and Two Thousand Dollars (\$2,000.00), from Respondent Berglan's multicounty agent bail bondsman deposit and forward it to the Beckham County District Court for payment of the bond forfeiture.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless either Respondent requests a hearing with respect to the Findings of Fact set forth above within thirty (30) days of the date of this Conditional Order, the penalties set forth above shall become a Final Order on the thirty-first (31st) day following the date of mailing this Order. A request for hearing should be in writing and addressed to Teresa L. Green, Oklahoma Insurance Department, Legal Division, 3625 NW 56th St., Suite 100, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order.

Any such hearing will be conducted according to the procedures for contested cases under the Insurance Code and 75 O.S. § 250 et seq. If the Respondent serves a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order will act as notice of the matters to be reviewed at the hearing, and the Findings of Fact, Conclusions of Law, and penalties imposed in this Conditional Order will be considered withdrawn, pending final resolution at the hearing.


