FINAL ADMINISTRATIVE ORDER

This matter is a disciplinary proceeding under the Oklahoma Producer Licensing Act. 36 O.S. §§ 1435.1 et seq. On November 4, 2020, a show cause hearing was held at the Oklahoma Insurance Department ("OID") on OID's Notice of Hearing and Order to Show Cause ("Notice"), filed September 2, 2020. The hearing was held at the offices of OID before Independent Hearing Examiner John Miller. Present at the hearing were Antuanya "Bo" DeBose, Assistant General Counsel for OID, April Moore for OID's Anti-Fraud Division and Maria Torres for OID's Legal Division. After several attempts at service, Respondent Davy Clint Adams ("Respondent") failed to appear.

Witnesses were sworn and testified, exhibits were admitted, and argument of the parties heard.

FINDINGS OF FACT

- 1. The OID has jurisdiction over the subject matter of this action pursuant to 36 O.S. §\$101-7401, including the Oklahoma Producer Licensing Act, 36 O.S. §1435.1 et seq.
- 2. That the Insurance Commissioner has the authority to render an Order concerning the above styled matter and has lawfully appointed Independent Hearing Examiner, John

Miller, who shall sit as a quasi-judicial officer pursuant to 36 O.S. §319.

- 3. Respondent holds a resident producer license number 103400 and is licensed by the State of Oklahoma. Respondent's address of record is 2600 Lakewood Drive, Chickasha, Oklahoma 73018-6163.
- 4. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act 36 O.S. 1435.13(A) and (D).
- 5. Petitioner afforded Respondent an opportunity for hearing by sending the *Notice* by certified mail return receipt requested and by first class U.S. mail on September 2, 2020 to Respondent at his address of record with the Department. The *Notice*, filed on September 2, 2020, stated the matters asserted, and stated the time, place, and nature of the hearing, cited legal authority and jurisdiction, and referred to particular sections of the statutes involved.
- 6. The hearing was recorded electronically by an employee of the Oklahoma Insurance Department. Neither party requested a full stenographic record of the proceedings.
- 7. The following exhibits were introduced and admitted:
 - **a.** Exhibit A: OID's Conditional Administrative Order and Notice of Right to be Heard for 18-0752-DIS filed October 15, 2018.
 - **b.** Exhibit B: Criminal Information for CF-2019-95 from Grady County filed April 30, 2019.
 - c. Exhibit C: OID Minute for 18-0752-DIS filed November 6, 2018.
 - d. Exhibit D: Letter from Allstate to OID Investigator April Moore dated October

- 1, 2019.
- e. Exhibit E: Email from ADA Shayne Melton to OID Investigator April Moore dated January 14, 2020.
- 8. The following witnesses were sworn and testified under oath:
 - a. Maria Torres, with OID Legal Division
 - **b.** April Moore, Investigator with OID.
- 9. On October 15, 2018, OID filed and mailed by certified mail and first class mail a Conditional Administrative Order, fining Respondent five hundred dollars (\$500.00) and ordering him to provide a response to OID regarding complaints made by consumers. A copy of the Conditional Administrative Order was also emailed to Respondent at his address of record. Respondent failed to pay the fine or provide a response to OID. (See *Exhibit A*, *Exhibit C* and the testimony of Maria Torres).
- 10. Allstate assigned investigator Michael Nutt to investigate Respondent. OID assigned Investigator April Moore to investigate Respondent as well. During the investigation, six (6) consumers were identified as making premium payments to Respondent, but then received no credit towards their accounts. Respondent took the consumers' payment and issued an internal receipt, but then fail to credit the money to the consumers' respective account. Respondent would instead keep the money for himself. The consumers provided documentation which included checks and receipts as proof of their payment. Allstate referred the matter to the Grady County District Attorney. (See testimony of April Moore and *Exhibit B*).
- 11. Allstate terminated Respondent's appointment with their company for withholding and misappropriating up to six (6) consumer's premium payments. (See *Exhibit D* and

testimony of April Moore).

12. As a result of misappropriating six (6) consumer's premium payments, Respondent was charged with one count of Embezzlement in Grady County Oklahoma case number CF-2019-00095. Respondent paid the restitution in full and the case was dismissed. (See *Exhibit B*, *Exhibit E*, and the testimony of April Moore).

CONCLUSIONS OF LAW

- 13. That OID has jurisdiction over this matter and Respondent pursuant to 36 O.S. 1435.1 et seq.
- 14. That Respondent is licensed by OID as a resident producer pursuant to 36 O.S. §1435.1 et seq.
- 15. That Respondent was provided adequate notice and a hearing pertaining to the *Notice*, in accordance with the Oklahoma Insurance Code and Oklahoma Administrative Procedures Act.
- 16. Based upon the provided findings of fact there is clear and convincing evidence to find that Respondent violated the following:
 - a. 36 O.S. §1435.13(A)(2) by failing to comply with the "Conditional Administrative Order and Notice of Right to be Heard" filed and mailed to Respondent October 15, 2018. Respondent did not pay the five hundred dollar (\$500.00) fine or provide a response to OID's inquiry.
 - b. 36 O.S. §1435.13(A)(4) by improperly withholding and misappropriating up to six (6) consumers' premium payments.
- 17. Pursuant to the provisions of 36 O.S. §1435.13, the Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued

pursuant to the Oklahoma Producer Licensing Act or may levy a civil penalty of not less than one hundred dollars (\$100.00) nor more than one thousand dollars (\$1,000.00) for each occurrence. Said penalty may be enforced in the same manner in which civil judgements may be enforced.

ORDER

IT IS THEREFORE ORDERED that Respondent Davy Clint Adams's resident producer license number 103400 is hereby revoked. Respondent is ordered to pay the costs of the proceeding in the amount of one hundred forty-five dollars (\$145.00) and is fined five hundred dollars (\$500.00) per each of the six (6) incidents of misappropriation of insurance premiums for a total fine of three thousand dollars (\$3,000.00 total.) The Insurance Commissioner shall notify all appointing insurers of the revocation and shall notify the Central Office of the National Association of Insurance Commissioners of Respondent's revocation.


