**CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE
HEARD**

COMES NOW the State of Oklahoma, ex rel., Glen Mulready, Insurance Commissioner,
by and through counsel, and alleges and states as follows:

JURISDICTION

1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma, and as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., including the Oklahoma Bail Bondsmen Code, 59 O.S. §§ 1301-1341.

2. Michael Campbell ("Respondent") is a licensed bail bondsman in the State of Oklahoma holding license #100133998. His address of record is 480 24th Ave NW Ste 110, Norman, Oklahoma 73069-6564.

3. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. § 1310.

ALLEGATIONS OF FACT

4. Pursuant to 59 O.S. § 1314(B) and Oklahoma Administrative Code § 365:25-5-36(a), a licensed bail bondsman shall electronically submit to the Insurance Commissioner (the "Commissioner") monthly reports for each line of authority within fifteen (15) days after the end of each preceding month – even if no bonds were written under any particular component of the license during that month.

5. Respondent submitted his February 2020 report four (4) days late on March 20, 2020. The report was due no later than March 16, 2020.

6. Respondent submitted his March 2020 report six (6) days late on April 21, 2020. The report was due no later than April 15, 2020.

7. Respondent submitted his April 2020 report three (3) days late on May 18, 2020. The report was due no later than May 15, 2020.

8. Respondent submitted his May 2020 report two (2) days late on June 17, 2020. The report was due no later than June 15, 2020.

9. Respondent submitted his June 2020 report six (6) days late on July 21, 2020. The report was due no later than July 15, 2020.

ALLEGED VIOLATIONS OF LAW

10. Respondent has violated 59 O.S. §§ 1310(A)(2) and (A)(24) on five (5) occasions by failing to timely file monthly reports for the months of February, March, April, May, and June of 2020 as required by 59 O.S. § 1314(B) and Okla. Admin. Code § 365:25-5-36.

11. Pursuant to 59 O.S. § 1310(A), the Insurance Commissioner may deny, censure, suspend, revoke, or refuse to renew any license issued pursuant to the Oklahoma Bail Bond Act.

12. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure,

suspension, or revocation, any person found in violation of any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

ORDER

IT IS THEREFORE ORDERED, ADJUDGED, AND DECREED by the Insurance Commissioner, subject to the following paragraph, that Respondent is hereby **FINED** in the amount of **Two Hundred Fifty Dollars (\$250.00)** for a continuous violation of 59 O.S. § 1310(A)(2) and (A)(24) during 2020. The **\$250.00** fine is to be paid within **thirty (30) days of the date** of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless Respondent requests a hearing within **thirty (30) days of the date of mailing** of this Conditional Order, the penalties set forth above will become a Final Order on **the thirty-first (31st) day** following the date of mailing of this Order. A request for hearing shall be made in writing to Kayla M. Rochelle, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 400 NE 50th Street, Oklahoma City, Oklahoma 73105. The request for hearing must state the grounds for the request to set aside or modify this Conditional Order and must be served on the Oklahoma Insurance Department within the thirty (30) days allotted. Upon such request, a hearing shall be conducted before an independent hearing examiner.

The hearing will be conducted in accordance with the Oklahoma Bail Bond Act, 59 O.S. §§ 1301 et seq. and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 et seq. If Respondent timely serves a request for hearing, this Conditional Order shall act as a notice of the

matters to be reviewed at the hearing, and the Allegations of Fact, Alleged Violations of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution of this matter through hearing.





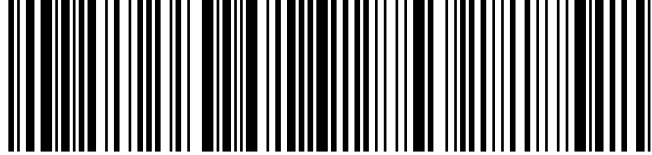
