CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, by and through counsel, Antuanya "Bo" DeBose, and alleges and states as follows:

JURISDICTION

- 1. Glen Mulready is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7401, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Kenne Warren Carroll ("Respondent Carroll") is a licensed bail bondsman in the State of Oklahoma holding license number 100247135. Respondent Carroll's address of record is 5690 W. Pace Road, Tishomingo, Oklahoma 73460-4648.
- 3. Respondent Stacy Ellis Cain ("Respondent Cain") is a multicounty agent bondsman in the State of Oklahoma holding license number 112423. Respondent Cain's address of record is 1805 N. Broadway Avenue, Ada, Oklahoma 74820-1407.

- 4. The Insurance Commissioner has jurisdiction over the subject matter raised in this dispute and may issue penalties pursuant to 59 O.S. §§ 1310 and 1332.
- 5. Pursuant to 59 O.S. § 1310(B), in addition to any potential denial, censure, suspension, or revocation, any person violating any provision of the Oklahoma Bail Bond Act may be subject to a civil penalty of not less than \$250.00 nor more than \$2,500.00 for each occurrence.
- 6. If Respondents request a hearing in writing in this matter, pursuant to OAC 365:1-7-1, the Insurance Commissioner, pursuant to 59 O.S. § 1311.1, will appoint an independent hearing examiner who shall sit as a quasi-judicial officer and preside over the hearing requested by Respondents.
- 7. The Insurance Commissioner, pursuant to OAC 365:1-7-5, upon written request reasonably made by a person affected by the hearing and at such person's expense, shall cause a full stenographic record of the proceedings to be made by a competent court reporter.

FINDINGS OF FACT

8. On or about January 4, 2019, an appearance bond was executed as follows:

9. On or about December 6, 2019 the Defendant failed to appear and the bond was declared forfeited. An Order and Judgment of Forfeiture was issued on or about December 13, 2019 by the Murray County District Court. A true and correct copy of the Order and Judgment of Forfeiture was mailed to Respondent Carroll and Respondent Cain to their address of record with return receipt requested within thirty (30) days after the Order's filing.

- 10. Respondent Carroll's copy of the Order and Judgement of Forfeiture was received December 16, 2019.
- 11. Respondent Cain's copy of the Order and Judgement of Forfeiture was received December 16, 2019.
- 12. The ninety-first (91st) day after receipt of the Order and Judgment of Forfeiture, pursuant with SCAD-2020-36, was May 18, 2020.
- 13. The forfeiture was untimely paid September 9, 2021.

CONCLUSIONS OF LAW

14. Respondents have violated 59 O.S. §1310(A)(6) and (28), by failing to return the Defendant to custody within ninety (90) days or remit payment in the face amount of the bond forfeiture within 91 days from receipt of the Order and Judgment of Forfeiture in accordance with the provisions of 59 O.S. § 1332 and OAC 365:25-5-40 and 365:25-5-41.

ORDER

IT IS THEREFORE ORDERED by the Insurance Commissioner that both Respondent Carroll and Respondent Cain are FINED \$500.00. The fines are to be paid within 30 days of the date of this Conditional Administrative Order and made payable to the Oklahoma Insurance Department located at 400 NE 50th Street, Oklahoma City, Oklahoma 73112. Failure to comply with a proper order of the Commissioner will result in further administrative action.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that this Order is a Conditional Order. Unless either Respondent Carroll or

Respondent Cain request a hearing with respect to the Findings of Fact set forth above within 30 days of the date of this Conditional Order, the penalties set forth above will become a Final Order on the 31st day following the date of mailing this Order. A request for hearing should be in writing and addressed to Antuanya "Bo" DeBose, Oklahoma Insurance Department, Legal Division, 400 NE 50th Street, Oklahoma City, Oklahoma 73112. The request for hearing must state the grounds for the request to set aside or modify the Order and must be served on the Oklahoma Insurance Department within the 30 days allotted. The proceedings on such requested hearing will be conducted in accordance with the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq., and the Oklahoma Administrative Procedures Act, 75 O.S. §§ 250 through 324. If either Respondent Carroll or Respondent Cain serve a timely request for hearing on the Oklahoma Insurance Department, this Conditional Order will act as a notice of the matters to be reviewed at the hearing and the Findings of Fact, Conclusions of Law, and penalties imposed in this Conditional Order shall be considered withdrawn, pending final resolution at the hearing.




