## STATE OF OKLAHOMA PHARMACY CHOICE COMMISSION MEETING MINUTES JULY 15, 2021

New item that was entered is the Commission has approved of Restitution to be added. Final order will be signed by Chairperson of the Commission or Co-Chair; we will need to appoint a new Chairperson and Co-Chairperson once we have enough for quorum.

PBM Complaints and License Review – September 2020 through March 2021 violations are bucketed by different types of the violations. We have been able to resolve over 5,000 violations due to our bucketing procedure. We currently have 7 Cease-and-Desist Orders that were based on investigations that were initiated by OID. If they violate the Cease-and-Desist Order, we can and will bring before the Commission regarding the alleged violation(s).
