# **FINAL ADMINISTRATIVE ORDER**

COMES NOW the State of Oklahoma, ex rel. Kim Holland, Insurance Commissioner, by and through her attorney, Julie Meaders, and alleges and states as follows:

#### **JURISDICTION**

- 1. Kim Holland is the Insurance Commissioner of the State of Oklahoma and is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101 et seq.
- 2. Respondent is licensed by the State of Oklahoma as a resident insurance producer holding license number 40108816.
- 3. The Insurance Commissioner may place on probation, censure, suspend, revoke or refuse to issue or renew a license issued pursuant to the Oklahoma Producer Licensing Act and/or may levy a fine up to \$1,000.00 for each occurrence of a violation of the Oklahoma Insurance Code, 36 O.S. § 1435.13(A) and (D).

#### FINDINGS OF FACT

1. Respondent is licensed by the State of Oklahoma as a resident insurance producer holding license number 40108816. Respondent's address of record is

- 2. The Oklahoma Insurance Department was notified that Respondent's nonresident producer license was revoked in the State of Washington on June 28, 2010, for failing to respond to letters of inquiry from the Washington Insurance Department. The letters of inquiry sought information regarding an arrest and charge reflected on Respondent's fingerprint report received from the FBI.
- 3. A background check by the Oklahoma Insurance Department reflected that Respondent was charged with felony obtaining money under false pretenses on September 16, 2003 in Oklahoma County Case No. CF-2003-5102. That charge was dismissed on November 8, 2004 upon Respondent's payment of restitution. The background check also reflected that Respondent was recently charged with felony forgery in the second degree on June 24, 2010 in Oklahoma County Case No. CF-2010-4175 and that the preliminary hearing in that case is set for September 23, 2010.
- 4. The background check did not reveal that Respondent reported the Washington revocation within thirty (30) days of the final disposition of the matter to the Oklahoma Insurance Commissioner nor did Respondent report the recent criminal prosecution in Oklahoma County to the Oklahoma Insurance Commissioner.

### CONCLUSIONS OF LAW

- Respondent violated 36 O.S. § 1435.13(A)(2) by violating Washington state insurance law RCW 48.17.475 in failing to respond to letters of inquiry within fifteen business days.
- 2. Respondent violated 36 O.S. § 1435.13(A)(9) in having her nonresident producer license in the state of Washington revoked.

## ORDER

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Insurance Commissioner that the Administrative Order of Suspension Instanter entered in this matter on August 23, 2010 is a FINAL ADMINISTRATIVE ORDER, that no hearing was requested and Respondent's license is hereby REVOKED.
