CONDITIONAL ADMINISTRATIVE ORDER AND NOTICE OF RIGHT TO BE HEARD

COMES NOW the State of Oklahoma, ex rel. John D. Doak, Insurance Commissioner, by and through counsel, and alleges and states as follows:

JURISDICTION AND AUTHORITY

- 1. John D. Doak is the Insurance Commissioner of the State of Oklahoma and, as such, is charged with the duty of administering and enforcing all provisions of the Oklahoma Insurance Code, 36 O.S. §§ 101-7301, and the Oklahoma Bail Bond Act, 59 O. S. §§ 1301-1340.
- 2. Respondent Randall Cain ("Respondent" or "Cain") is a licensed bail bondsman in the State of Oklahoma holding license number 100258666.
- 3. Pursuant to 59 O.S. § 1310(B), any person violating any provision of Sections 1301 through 1340 may be subject to a civil penalty of not less than Two Hundred Fifty Dollars (\$250.00) nor more than Two Thousand Five Hundred Dollars (\$2,500.00) for each occurrence.

ALLEGATIONS OF FACT

1. On or about June 14, 2016, Cain paid a fifty dollar (\$50.00) fee owed by Defendant Kevin Reynolds in case number CF-2015-244, to the district court clerk in Stephen County, Oklahoma.

2. On that same date, Cain subsequently issued payment for an appearance bond in case number CM-2016-240; In the District Court of Stephens County, State of Oklahoma, State of Oklahoma v. Kevin James Reynolds.

VIOLATIONS OF LAW

1. Respondent has violated 59 O.S. § 1310(A) (19) by paying a fee or rebating or giving or promising anything of value to the principal or anyone in the behalf of the principal.

ORDER

IT IS THEREFORE ORDERED that Randall Cain is CENSURED and FINED Two Hundred Fifty Dollars (\$250.00). The fine is to be paid within thirty (30) days of receipt of order. Failure to pay the fine within the thirty (30) days allotted shall result in suspension of license.

Respondent is further notified that he may request a hearing within thirty (30) days of receipt of this Order, and upon such request, the Oklahoma Insurance Department shall conduct a hearing before an independent hearing examiner. A request for hearing shall be made in writing to Sara A. Worten, Assistant General Counsel, Oklahoma Insurance Department, Legal Division, 3625 NW 56th Suite 100, Oklahoma City, Oklahoma 73112, and shall specify the grounds to be relied upon as a basis for relief demanded at the hearing.

If Respondent does not request a hearing within the 30 days allotted, this Conditional Administrative Order shall become a FINAL ORDER on the 31st day following Respondent's receipt of the Order.
