MEMORANDUM OF AGREEMENT

OKLAHOMA INSURANCE DEPARTMENT CASE NO. 18-0011-DIS

The Petitioner, Oklahoma Insurance Department (the "OID"), ex rel. John D. Doak, Insurance Commissioner, and Respondents, Jeffrey Scott Mann ("Mann") and FarmAssure LLC ("FarmAssure"), hereby enter into the following Memorandum of Agreement disposing of the *Administrative Order of Suspension Instante* (the "Order") issued on January 9, 2018, as authorized by 75 O.S. § 309(E):

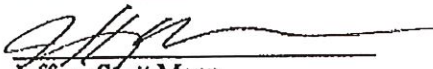
Respondents Mann and FarmAssure hereby agree to discontinue in its entirety the marketing of the farmowners insurance program offered in conjunction with Rockingham Casualty Company ("Rockingham") in the State of Oklahoma.

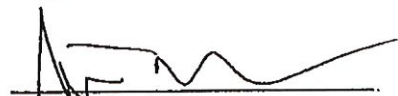
