MOTION FOR CONTINUANCE

COMES NOW the State of Oklahoma, ex rel. Glen Mulready, Insurance Commissioner, , by and through counsel, Antuanya “Bo” DeBose and Nicole Nash, and respectfully requests this Hearing Examiner continue the Pre-Hearing Conference currently set for August 26, 2026 at 9:00am, and in support states as follows:

1. On July 28, 2026, the Honorable John D. Miller, Independent Hearing Examiner, entered an Order, filed July 29, 2026, granting the Oklahoma Insurance Department's (the “Department’s”) Motion for Pre-Hearing Conference and Deadline to File Entry of Appearances. That Order sets a pre-hearing conference for **August 27, 2026, at 9:30 a.m., via Microsoft Teams**, and identifies issues for determination at that conference.

2. On August 26, 2026, at approximately 11:55 a.m., the Department’s Administrative Court Clerk circulated the thirty-one (31) page *Omnibus Pre-Hearing Motion of the Oklahoma Attorney General* (the “Motion”) to all the Parties who had filed an entry of appearance at that time. On the same date, at approximately 1:38 p.m., the Department received the Motion via email from the Whitten Burrage law firm. Including exhibits, the Motion is ninety (90) pages.

Due to the Motion being filed and served so shortly before the Pre-Hearing Conference, the Department, despite best efforts, is unable to draft and file an adequate response to the Motion so shortly before the scheduled pre-hearing conference and requests additional time to submit a response and proposed stipulations to the Motion prior to the pre-hearing conference.

WHEREFORE, premises considered, the Department respectfully requests this Hearing Examiner grant a short continuance of the pre-hearing conference scheduled in the above styled case.
