At the request of the Oklahoma P&C Advocacy Association, over the objection of the Oklahoma Attorney General, Bob Sullivan, the National Association of Mutual Insurance Companies, Inc. and the American Property and Casualty Insurance Association, and without objection from the Department, the hearing for the purpose of determining whether the homeowner's insurance market in Oklahoma is noncompetitive previously scheduled for September 14, 2026 at 09:00 o'clock a.m. is hereby continued until **October 26, 2026 at 09:00 o'clock a.m.** and will be held at the Oklahoma State Capitol, Multi-Purpose Room 100, 2300 N. Lincoln Blvd., Oklahoma City, Oklahoma 73105.

6. The deadline for all parties to file their list of exhibits which will be presented at the October 26, 2026 hearing shall be determined at the next pre-hearing conference held in this matter.
